A bill to amend 1981 PA 125, entitled
"The secondary mortgage loan act,"
by amending the title and sections 1, 2, 6, 6a, 6b, 11, 13, 20, 22, and 27 (MCL 493.51, 493.52, 493.56, 493.56a, 493.56b, 493.61, 493.63, 493.70, 493.72, and 493.77), the title and sections 6, 11, 13, 20, 22, and 27 as amended and section 6a as added by 1997 PA 91, sections 1 and 6b as amended by 2002 PA 392, and section 2 as amended by 2007 PA 46, and by adding sections 2a, 2b, 2c, 2d, and 26a.

- 2 An act to regulate secondary mortgage loans; TO REGULATE

- 1 SECONDARY MORTGAGE BROKERS, LENDERS, SERVICERS, AND LOAN OFFICERS;

- (h) "Lender" means a person who, directly or indirectly, makes

- 22 (i) "Licensee" means a person licensed or required to be
- 23 licensed under this act. A licensee does not include a depository
- 24 financial institution.
- 25 (j) "Loan servicing customer" means a mortgagor whose
- 26 secondary mortgage loan is being serviced by a servicer.
- 27 (k) "Open-end credit" means credit extended under a plan in

- 2 (i) The licensee or registrant reasonably contemplates repeated
- 3 transactions.
- 4 (ii) The amount of credit that may be extended to the borrower

- 18 mortgage servicing agreement, or an agreement with the A mortgagor.
