## SUBSTITUTE FOR SENATE BILL NO. 1423

- 2 (A) "ALTERNATIVE DISPUTE RESOLUTION" MEANS A PROCESS

- 23 (g) To investigate all relevant facts, and to make a written
- 24 report and recommendation to the parties and to the court,

- 27 domestic relations mediation is refused by either party or is

- 23 (h) To investigate all relevant facts and to make a written
- 24 report and recommendation to the parties and their attorneys and to
- 25 the court regarding child support, if ordered to do so by the
- 26 court. The written report and recommendation shall be placed in the
- 27 court file. The investigation may include reports and evaluations

- 1 by outside persons or agencies if requested by the parties or the
- 2 court, and shall include documentation of alleged facts, if
- 3 practicable. If requested by a party, an investigation shall
- 4 include a meeting with the party. The child support formula
- 5 developed by the bureau under section 19 shall be used as a
- 6 guideline in recommending child support. The written report shall
- 7 include the support amount determined by application of the child
- 8 support formula and all factual assumptions upon which that support
- 9 amount is based. If the office of the friend of the court
- 10 determines from the facts of the case that application of the child
- 11 support formula would be unjust or inappropriate, the written

- 19 (2) If a party who requests a meeting during an investigation
- 20 fails to attend the scheduled meeting without good cause, the
- 21 investigation may be completed without a meeting with that party.
- 22 (3) THE FRIEND OF THE COURT DOES NOT HAVE ANY DUTY RELATED TO
- 23 SPOUSAL SUPPORT UNLESS THE SPOUSAL SUPPORT IS ORDERED BEFORE APRIL
- 24 1, 2009 OR THE SPOUSAL SUPPORT IS TO BE PAID TO A PARTY WHO
- 25 RECEIVES TITLE IV-D SERVICES FOR THE ENFORCEMENT OF A CHILD SUPPORT
- 26 ORDER. THE FRIEND OF THE COURT MAY PROVIDE SERVICES WITH REGARD TO

- 3 the friend of the court shall open and maintain a friend of the

- 5 friend of the court case for a domestic relations matter, the
- 6 office of the friend of the court shall administer and enforce the
- 7 obligations of the parties to the friend of the court case as
- 8 provided in this act. If there is not an open friend of the court
- 9 case for a domestic relations matter, the office of the friend of
- 10 the court shall not administer or enforce an obligation of a party
- 11 to the domestic relations matter.
- 12 (2) The parties to a domestic relations matter are not
- 13 required to have a friend of the court case opened or maintained
- 14 for their domestic relations matter. With their initial pleadings,
- 15 the parties to a domestic relations matter may file a motion for
- 16 the court to order the office of the friend of the court not to
- 17 open a friend of the court case for the domestic relations matter.
- 18 If the parties to a domestic relations matter file a motion under
- 19 this subsection, the court shall issue that order unless the court
- 20 determines 1 or more of the following:
- 21 (a) A party to the domestic relations matter is eligible for
- 22 title IV-D services because of the party's current or past receipt
- 23 of public assistance.
- 24 (b) A party to the domestic relations matter applies for title
- 25 IV-D services.
- 26 (c) A party to the domestic relations matter requests that the
- 27 office of the friend of the court open and maintain a friend of the

- 1 court case for the domestic relations matter, even though the party
- 2 may not be eligible for title IV-D services because the domestic
- 3 relations matter involves, by way of example and not limitation,
- 4 only spousal support, child custody, parenting time, or child
- 5 custody and parenting time.
- 6 (d) There exists in the domestic relations matter evidence of
- 7 domestic violence or uneven bargaining positions and evidence that
- 8 a party to the domestic relations matter has chosen not to apply
- 9 for title IV-D services against the best interest of either the
- 10 party or the party's child.
- 11 (e) The parties have not filed with the court a document,
- 12 signed by each party, that includes a list of the friend of the
- 13 court services and an acknowledgment that the parties are choosing
- 14 to do without those services.
- 15 (3) If a friend of the court case is not opened for a domestic
- 16 relations matter, the parties to the domestic relations matter have
- 17 full responsibility for administration and enforcement of the
- 18 obligations imposed in the domestic relations matter.
- 19 (4) The parties to a friend of the court case may file a
- 20 motion for the court to order the office of the friend of the court
- 21 to close their friend of the court case. The court shall issue an
- 22 order that the office of the friend of the court shall close the
- 23 friend of the court case unless the court determines 1 or more of
- 24 the following:
- 25 (a) A party to the friend of the court case objects.
- 26 (b) A party to the friend of the court case is eligible for
- 27 title IV-D services because the party is receiving public

- 1 assistance.
- 2 (c) A party to the friend of the court case is eligible for
- 3 title IV-D services because the party received public assistance
- 4 and an arrearage is owed to the governmental entity that provided
- 5 the public assistance.
- 6 (d) The friend of the court case record shows that, within the
- 7 previous 12 months, a child support arrearage or custody or
- 8 parenting time order violation has occurred in the case.
- 9 (e) Within the previous 12 months, a party to the friend of
- 10 the court case has reopened a friend of the court case.
- 11 (f) There exists in the friend of the court case evidence of
- 12 domestic violence or uneven bargaining positions and evidence that
- 13 a party to the friend of the court case has chosen to close the
- 14 case against the best interest of either the party or the party's
- 15 child.
- 16 (g) The parties have not filed with the court a document,
- 17 signed by each party, that includes a list of the friend of the
- 18 court services and an acknowledgment that the parties are choosing
- 19 to do without those services.
- 20 (5) The closure of a friend of the court case does not release
- 21 a party from the party's obligations imposed in the underlying
- 22 domestic relations matter. The parties to a closed friend of the
- 23 court case assume full responsibility for administration and
- 24 enforcement of obligations imposed in the underlying domestic
- 25 relations matter.
- 26 (6) If a party to the underlying domestic relations matter
- 27 wants to ensure that child support payments made after a friend of

- 1 the court case is closed will be taken into account in any possible
- 2 future office of the friend of the court enforcement action, the
- 3 child support payments must be made through the SDU. If the parties
- 4 choose to continue to have child support payments made through the
- 5 SDU, the office of the friend of the court shall not close its
- 6 friend of the court case until each party provides the SDU with the
- 7 information necessary to process the child support payments
- 8 required in the underlying domestic relations matter.
- 9 (7) If a party to a domestic relations matter for which there
- 10 is not an open friend of the court case applies for services from

- 7 Sec. 9a. The department, the SDU , and each office of the

- 10 disbursement of support and fees. An office of the friend of the
- 11 court shall MAY continue to receive and disburse support and fees.
