THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 4. (1) This act does not apply to either APPLIES TO ANY
 UNFAIR, UNCONSCIONABLE, OR DECEPTIVE METHOD, ACT, OR PRACTICE AND
 CREATES A CAUSE OF ACTION AGAINST A COMPANY WHO ENGAGES IN THAT
 METHOD, ACT, OR PRACTICE, EXCEPT FOR ANY of the following:

5 (a) A transaction or conduct specifically authorized under
6 laws administered by a regulatory board or officer acting under
7 statutory authority METHOD, ACT, OR PRACTICE THAT IS EXPRESSLY

(b) An act done by the A publisher, owner, agent, or employee

of a newspaper, periodical, directory, radio or television station, or other communications medium in the publication or dissemination of an advertisement unless the publisher, owner, agent, or employee knows or, under the circumstances, reasonably should know of the false, misleading, or deceptive character of the advertisement or has a direct financial interest in the sale or distribution of the advertised goods, property, or service.

(2) A PERSON WHO CLAIMS THIS ACT DOES NOT APPLY TO A METHOD,

 OTHER EXEMPTION FROM THIS ACT BEARS THE BURDEN OF PROVING THAT
 EXCEPTION OR EXEMPTION.

4 (3) AS USED IN THIS SECTION, "COMPANY" MEANS A PERSON ENGAGED 5 IN TRADE OR COMMERCE, INCLUDING, BUT NOT LIMITED TO, A PERSON WHOSE 6 PROFESSION, OCCUPATION, CONDUCT, OR TRANSACTIONS ARE REGULATED BY A 7 STATUTE, RULE, OR REGULATION OF THIS STATE OR THE UNITED STATES.
