

# HOUSE BILL No. 4391

A bill to amend 1956 PA 218, entitled  
"The insurance code of 1956,"  
(MCL 500.100 to 500.8302) by adding section 3406s.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1        SEC. 3406S. AN INSURER THAT DELIVERS, ISSUES FOR DELIVERY, OR  
2        RENEWS IN THIS STATE ON OR AFTER JANUARY 1, 2008 AN EXPENSE-  
3        INCURRED HOSPITAL, MEDICAL, OR SURGICAL POLICY OR CERTIFICATE AND A  
4        HEALTH MAINTENANCE ORGANIZATION THAT ISSUES OR RENEWS A GROUP OR  
5        INDIVIDUAL CONTRACT ON OR AFTER JANUARY 1, 2008 SHALL PROVIDE THAT  
6        COST-SHARING REQUIREMENTS AND BENEFIT OR SERVICE LIMITATIONS FOR  
7        OUTPATIENT MENTAL HEALTH AND OUTPATIENT SUBSTANCE ABUSE SERVICES DO  
8        NOT PLACE A GREATER FINANCIAL BURDEN ON THE INSURED OR ENROLLEE AND  
9        ARE NOT MORE RESTRICTIVE THAN THOSE REQUIREMENTS AND LIMITATIONS  
10       FOR OUTPATIENT MEDICAL SERVICES.
