Sec. 201. Pursuant to section 30 of article IX of the state
constitution of 1963, total state spending under part 1 for fiscal
year 2006-2007 is \$500,000.00. State payments to local units of
government under this act are \$0.00.

8 Sec. 202. The appropriations made and the expenditures
9 authorized under this act and the departments, agencies,
10 commissions, boards, offices, and programs for which an
11 appropriation is made under this act are subject to the management
12 and budget act, 1984 PA 431, MCL 18.1101 to 18.1594.

13 ENTREPRENEURIAL EDUCATION

14 Sec. 301. (1) The funds appropriated in part 1 for the 15 entrepreneurial education program shall be allocated to Michigan 4-16 year degree-granting public institutions for the purpose of 17 expanding an existing entrepreneurial undergraduate degree program. 18 The institution's entrepreneurial program must demonstrate a 19 continued relationship between local businesses and economic 20 development organizations and shall include an opportunity for 21 students to obtain practical experience. No institution shall 22 receive more than \$250,000.00.

23 (2) The funds shall be used for the existing entrepreneurial24 education programs to further the development of programs that

include, but are not limited to, internship support and mentor
 programs, student scholarship programs, and business plan and
 development programs. The fund may be used for undergraduate
 studies, for program expansion supporting continuing education, and
 as matching funds for foundation and federal grants to support
 entrepreneurial degree-related initiatives.
