3 (A) TRANSPORT THE INDIVIDUAL FOR THE PURPOSE OF ALLOWING THE 4 INDIVIDUAL TO SUBMIT AN APPLICATION TO OBTAIN AN OFFICIAL IDENTITY 5 DOCUMENT ISSUED BY THAT OFFICE.

14 (C) POSSESS AN IDENTITY DOCUMENT OBTAINED IN VIOLATION OF THIS15 SECTION.

16 (3) A PERSON WHO VIOLATES THIS SECTION IS GUILTY OF A FELONY
17 AND SHALL BE PUNISHED BY IMPRISONMENT FOR NOT LESS THAN 1 YEAR OR
18 MORE THAN 5 YEARS AND SHALL BE FINED NOT LESS THAN \$500.00 OR MORE
19 THAN \$5,000.00.

20 (4) AS USED IN THIS SECTION, "IDENTITY DOCUMENT" MEANS EITHER
21 OF THE FOLLOWING:

22 (A) A LICENSE TO OPERATE A MOTOR VEHICLE.

23 (B) AN OFFICIAL STATE IDENTITY CARD.
