"Identity theft protection act,"

by amending section 5 (MCL 445.65), as amended by 2006 PA 246.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 5. (1) A person shall not do any of the following:
- 2 (a) With intent to defraud or violate the law, use or attempt
- 3 to use the personal identifying information of another person to do
- 4 either of the following:
- 5 (i) Obtain credit, goods, services, money, property, a vital
- 6 record, a confidential telephone record, medical records or
- 7 information, or employment.
 - (ii) Commit another unlawful act ENGAGE IN CRIMINAL ACTIVITY OR
 - ANY OTHER VIOLATION OF LAW.

- 1 (iii) MISLEAD A LAW ENFORCEMENT AGENCY OR COURT CONCERNING THE
- 2 IDENTITY OF AN INDIVIDUAL UNDER CRIMINAL INVESTIGATION OR A

- 10 (ii) Commit another unlawful act.
- 11 (2) A person who violates subsection (1) (b) (i) may assert 1 or
- 12 more of the following as a defense in a civil action or as an
- 13 affirmative defense in a criminal prosecution, and has the burden
- 14 of proof on that defense by a preponderance of the evidence:
- 15 (a) That the person gave a bona fide gift for or for the
- 16 benefit or control of, or use or consumption by, the person whose
- 17 personal identifying information was used.
- 18 (b) That the person acted in otherwise lawful pursuit or
- 19 enforcement of a person's legal rights, including an investigation
- 20 of a crime or an audit, collection, investigation, or transfer of a
- 21 debt, child or spousal support obligation, tax liability, claim,
- 22 receivable, account, or interest in a receivable or account.
- 23 (c) That the action taken was authorized or required by state
- 24 or federal law, rule, regulation, or court order or rule.
- 25 (d) That the person acted with the consent of the person whose
- 26 personal identifying information was used, unless the person giving
- 27 consent knows that the information will be used to commit an
