A bill to amend 1949 PA 300, entitled "Michigan vehicle code,"

by amending section 310 (MCL 257.310), as amended by 2008 PA 36.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 310. (1) The secretary of state shall issue an operator's 1 2 license to each person licensed as an operator and a chauffeur's 3 license to each person licensed as a chauffeur. An applicant for a motorcycle indorsement under section 312a or a vehicle group 4 5 designation or indorsement shall first qualify for an operator's or 6 chauffeur's license before the indorsement or vehicle group 7 designation application is accepted and processed. An original license or the first renewal of an existing license issued to a person less than 21 years of age shall be portrait or vertical in 10 form and a license issued to a person 21 years of age or over shall

- 1 be landscape or horizontal in form.
- 2 (2) The license issued under subsection (1) shall contain all
- 3 of the following:
- 4 (a) The distinguishing number permanently assigned to the
- 5 licensee.
- 6 (b) The full legal name, date of birth, address of residence,
- 7 height, eye color, sex, digital photographic image, expiration
- 8 date, and signature of the licensee.
- 9 (c) In the case of a licensee who has indicated his or her
- 10 wish to participate in the anatomical gift donor registry under
- 11 part 101 of the public health code, 1978 PA 368, MCL 333.10101 to
- 12 333.10123, a heart insignia on the front of the license.
- 13 (d) Physical security features designed to prevent tampering,
- 14 counterfeiting, or duplication of the license for fraudulent
- 15 purposes.
- 16 (E) IF REQUESTED BY AN INDIVIDUAL WHO IS A VETERAN OF THE
- 17 ARMED FORCES OF THIS STATE, ANOTHER STATE, OR THE UNITED STATES, A
- 18 DESIGNATION THAT THE INDIVIDUAL IS A VETERAN. THE DESIGNATION SHALL
- 19 BE IN A STYLE AND FORMAT CONSIDERED APPROPRIATE BY THE SECRETARY OF
- 20 STATE AND MAY DESIGNATE THE MILITARY BRANCH OF WHICH THE INDIVIDUAL
- 21 WAS A MEMBER. THE SECRETARY OF STATE SHALL REQUIRE PROOF OF THE
- 22 INDIVIDUAL'S STATUS AS A VETERAN BEFORE PROVIDING THE DESIGNATION
- 23 REQUIRED UNDER THIS SECTION.
- 24 (3) Except as otherwise required under this chapter, other
- 25 information required on the license pursuant to this chapter may
- 26 appear on the license in a form prescribed by the secretary of
- 27 state.

- 1 (4) The license shall not contain a fingerprint or finger
- 2 image of the licensee.
- 3 (5) A digitized license may contain an identifier for voter
- 4 registration purposes. The digitized license may contain
- 5 information appearing in electronic or machine readable codes
- 6 needed to conduct a transaction with the secretary of state. The
- 7 information shall be limited to the person's driver license number,
- 8 birth date, full legal name, date of transaction, gender, address,
- 9 state of issuance, license expiration date, and other information
- 10 necessary for use with electronic devices, machine readers, or
- 11 automatic teller machines and shall not contain the driving record
- 12 or other personal identifier. The license shall identify the
- 13 encoded information.
- 14 (6) The license shall be manufactured in a manner to prohibit
- 15 as nearly as possible the ability to reproduce, alter, counterfeit,
- 16 forge, or duplicate the license without ready detection. In
- 17 addition, a license with a vehicle group designation shall contain
- 18 the information required under 49 CFR part 383.
- 19 (7) Except as provided in subsection (11), a person who
- 20 intentionally reproduces, alters, counterfeits, forges, or
- 21 duplicates a license photograph, the negative of the photograph,
- 22 image, license, or electronic data contained on a license or a part
- 23 of a license or who uses a license, image, or photograph that has
- 24 been reproduced, altered, counterfeited, forged, or duplicated is
- 25 subject to 1 of the following:
- (a) If the intent of the reproduction, alteration,
- 27 counterfeiting, forging, duplication, or use is to commit or aid in

- 1 the commission of an offense that is a felony punishable by
- 2 imprisonment for 10 or more years, the person committing the
- 3 reproduction, alteration, counterfeiting, forging, duplication, or
- 4 use is quilty of a felony, punishable by imprisonment for not more
- 5 than 10 years or a fine of not more than \$20,000.00, or both.
- 6 (b) If the intent of the reproduction, alteration,
- 7 counterfeiting, forging, duplication, or use is to commit or aid in
- 8 the commission of an offense that is a felony punishable by
- 9 imprisonment for less than 10 years or a misdemeanor punishable by
- 10 imprisonment for 6 months or more, the person committing the
- 11 reproduction, alteration, counterfeiting, forging, duplication, or
- 12 use is guilty of a felony, punishable by imprisonment for not more
- 13 than 5 years, or a fine of not more than \$10,000.00, or both.
- (c) If the intent of the reproduction, alteration,
- 15 counterfeiting, forging, duplication, or use is to commit or aid in
- 16 the commission of an offense that is a misdemeanor punishable by
- 17 imprisonment for less than 6 months, the person committing the
- 18 reproduction, alteration, counterfeiting, forging, duplication, or
- 19 use is guilty of a misdemeanor punishable by imprisonment for not
- 20 more than 1 year or a fine of not more than \$2,000.00, or both.
- 21 (8) Except as provided in subsections (11) and (16), a person
- 22 who sells, or who possesses with the intent to deliver to another,
- 23 a reproduced, altered, counterfeited, forged, or duplicated license
- 24 photograph, negative of the photograph, image, license, or
- 25 electronic data contained on a license or part of a license is
- 26 quilty of a felony punishable by imprisonment for not more than 5
- 27 years or a fine of not more than \$10,000.00, or both.

- 1 (9) Except as provided in subsections (11) and (16), a person
- 2 who is in possession of 2 or more reproduced, altered,
- 3 counterfeited, forged, or duplicated license photographs, negatives
- 4 of the photograph, images, licenses, or electronic data contained
- 5 on a license or part of a license is quilty of a felony punishable
- 6 by imprisonment for not more than 5 years or a fine of not more
- 7 than \$10,000.00, or both.
- 8 (10) Except as provided in subsection (16), a person who is in
- 9 possession of a reproduced, altered, counterfeited, forged, or
- 10 duplicated license photograph, negative of the photograph, image,
- 11 license, or electronic data contained on a license or part of a
- 12 license is guilty of a misdemeanor punishable by imprisonment for
- 13 not more than 1 year or a fine of not more than \$2,000.00, or both.
- 14 (11) Subsections (7)(a) and (b), (8), and (9) do not apply to
- 15 a minor whose intent is to violate section 703 of the Michigan
- 16 liquor control code of 1998, 1998 PA 58, MCL 436.1703.
- 17 (12) The secretary of state, upon determining after an
- 18 examination that an applicant is mentally and physically qualified
- 19 to receive a license, may issue the applicant a temporary driver's
- 20 permit. The temporary driver's permit entitles the applicant, while
- 21 having the permit in his or her immediate possession, to drive a
- 22 motor vehicle upon the highway for a period not exceeding 60 days
- 23 before the secretary of state has issued the applicant an
- 24 operator's or chauffeur's license. The secretary of state may
- 25 establish a longer duration for the validity of a temporary
- 26 driver's permit if necessary to accommodate the process of
- 27 obtaining a background check that is required for an applicant by

- 1 federal law.
- 2 (13) An operator or chauffeur may indicate on the license in a
- 3 place designated by the secretary of state his or her blood type,
- 4 emergency contact information, immunization data, medication data,
- 5 or a statement that the licensee is deaf.
- 6 (14) An operator or chauffeur may indicate on the license in a
- 7 place designated by the secretary of state that he or she has
- 8 designated a patient advocate in accordance with sections 5506 to
- 9 5515 of the estates and protected individuals code, 1998 PA 386,
- **10** MCL 700.5506 to 700.5515.
- 11 (15) If the applicant provides proof to the secretary of state
- 12 that he or she is a minor who has been emancipated under 1968 PA
- 13 293, MCL 722.1 to 722.6, the license shall bear the designation of
- 14 the individual's emancipated status in a manner prescribed by the
- 15 secretary of state.
- 16 (16) Subsections (8), (9), and (10) do not apply to a person
- 17 who is in possession of 1 or more photocopies, reproductions, or
- 18 duplications of a license to document the identity of the licensee
- 19 for a legitimate business purpose.
- 20 (17) A sticker or decal may be provided by any person,
- 21 hospital, school, medical group, or association interested in
- 22 assisting in implementing an emergency medical information card,
- 23 but shall meet the specifications of the secretary of state. An
- 24 emergency medical information card may contain information
- 25 concerning the licensee's patient advocate designation, other
- 26 emergency medical information, or an indication as to where the
- 27 licensee has stored or registered emergency medical information.

- 1 (18) The secretary of state shall inquire of each licensee, in
- 2 person or by mail, whether the licensee agrees to participate in
- 3 the anatomical gift donor registry under part 101 of the public
- 4 health code, 1978 PA 368, MCL 333.10101 to 333.10123.
- 5 (19) A licensee who has agreed to participate in the
- 6 anatomical gift donor registry under part 101 of the public health
- 7 code, 1978 PA 368, MCL 333.10101 to 333.10123, shall not be
- 8 considered to have revoked that agreement solely because the
- 9 licensee's license has been revoked or suspended or has expired.
- 10 Enrollment in the donor registry constitutes a legal agreement that
- 11 remains binding and in effect after the donor's death regardless of
- 12 the expressed desires of the deceased donor's next of kin who may
- 13 oppose the donor's anatomical gift.
