A bill to amend 1967 PA 281, entitled "Income tax act of 1967,"

(MCL 206.1 to 206.532) by adding section 523.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 523. (1) FOR TAX YEARS BEGINNING AFTER DECEMBER 31, 2006,
- 2 IF A QUALIFIED CLAIMANT IS ELIGIBLE TO RECEIVE A CREDIT UNDER
- 3 SECTIONS 520 AND 522, THE DEPARTMENT SHALL PAY THE AMOUNT OF THE
- 4 CREDIT DUE TO THE QUALIFIED CLAIMANT NO LATER THAN THE SEVENTH
- 5 BUSINESS DAY AFTER THE DEPARTMENT RECEIVES THE CLAIM FOR THE
- 6 CREDIT.
- (2) INTEREST AT THE RATE CALCULATED UNDER SECTION 23 OF 1941
- PA 122, MCL 205.23, FOR DEFICIENCIES IN TAX PAYMENTS SHALL BE ADDED
- TO THE AMOUNT OF THE CLAIM UNDER THIS SECTION BEGINNING ON THE

- 1 EIGHTH DAY AFTER THE CLAIM IS FILED OR THE EIGHTH DAY AFTER THE
- 2 DATE ESTABLISHED BY LAW FOR THE FILING OF THE CLAIM UNDER SECTIONS
- 3 520 AND 522, WHICHEVER IS LATER.
- 4 (3) AS USED IN THIS SECTION:
- 5 (A) "BLIND" MEANS THAT THE SIGHT IN AN INDIVIDUAL'S BETTER EYE
- 6 IS PERMANENTLY 20/200 OR LESS WITH CORRECTIVE LENSES OR THE
- 7 INDIVIDUAL'S PERIPHERAL FIELD OF VISION IS 20 DEGREES OR LESS.
- 8 (B) "DEAF" MEANS THE PRIMARY MEANS OF RECEIVING MESSAGES IS
- 9 THROUGH A SENSE OTHER THAN HEARING, INCLUDING, BUT NOT LIMITED TO,
- 10 LIP READING OR SIGN LANGUAGE.
- 11 (C) "QUALIFIED CLAIMANT" MEANS AN INDIVIDUAL, HIS OR HER
- 12 SPOUSE, OR THE UNREMARRIED SURVIVING SPOUSE OF AN INDIVIDUAL WHO
- 13 MEETS 1 OF THE FOLLOWING CRITERIA ON THE LAST DAY OF THE CALENDAR
- 14 YEAR FOR WHICH THE CLAIM UNDER SECTIONS 520 AND 522 IS FILED:
- 15 (i) IF THE CLAIMANT IS MARRIED AND THE CLAIMANT'S SPOUSE MEETS
- 16 THE CRITERIA UNDER THIS SUBDIVISION, THE CLAIMANT AND HIS OR HER
- 17 SPOUSE BOTH LIVE IN THE HOMESTEAD ON WHICH THE CLAIM IS BASED.
- 18 (ii) IS A SENIOR CITIZEN.
- 19 (iii) IS TOTALLY AND PERMANENTLY DISABLED AS DEFINED IN SECTION
- 20 522.
- 21 (iv) IS PARAPLEGIC, QUADRIPLEGIC, OR HEMIPLEGIC.
- (v) IS BLIND OR DEAF.
- 23 (D) "SENIOR CITIZEN" MEANS AN INDIVIDUAL WHO IS 65 YEARS OF
- 24 AGE OR OLDER.
