SENATE BILL No. 901

November 8, 2007, Introduced by Senators CROPSEY, BIRKHOLZ, KAHN, RICHARDVILLE, BROWN, PAPPAGEORGE, GLEASON, JANSEN, VAN WOERKOM and HARDIMAN and referred to the Committee on Natural Resources and Environmental Affairs.

A bill to amend 1994 PA 451, entitled "Natural resources and environmental protection act," (MCL 324.101 to 324.90106) by adding sections 8911, 8913, and 8915.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 8911. (1) TRAVEL MICHIGAN, ASSISTED BY THE DEPARTMENT OF
- 2 ENVIRONMENTAL QUALITY AND THE DEPARTMENT OF NATURAL RESOURCES,
- 3 SHALL DEVELOP AND ADMINISTER A MARKETING PROGRAM DESIGNED TO REDUCE
- 4 THE INCIDENCE OF LITTERING IN THIS STATE.
 - (2) IN ADMINISTERING THE MARKETING PROGRAM DEVELOPED UNDER
- THIS SECTION, TRAVEL MICHIGAN SHALL DO BOTH OF THE FOLLOWING:
 - (A) USE A SINGLE MARKETING SLOGAN, DEVELOPED AT LEAST IN PART
- FROM SUGGESTIONS BY CHILDREN WHO ATTEND SCHOOLS IN THIS STATE.
 - (B) COORDINATE THE MARKETING PROGRAM WITH THIS STATE'S RECYCLING PROGRAM.

- 14 SEC. 8913. THE STATE TRANSPORTATION DEPARTMENT SHALL PROVIDE A
- 15 VOLUNTEER GROUP CONDUCTING LITTER CLEANUP UNDER ITS ADOPT-A-HIGHWAY
- 16 PROGRAM WITH DATA INFORMATION SHEETS AND SHALL REQUEST THAT THE
- 17 VOLUNTEER GROUP RECORD ON THE DATA INFORMATION SHEETS A GENERAL
- 18 CHARACTERIZATION OF THE TYPES AND AMOUNT OF TRASH COLLECTED DURING
- 19 THE GROUP'S CLEANUP EFFORT. THE STATE TRANSPORTATION DEPARTMENT
- 20 SHALL REQUEST THE GROUP TO FORWARD THE DATA INFORMATION SHEETS TO
- 21 THE DEPARTMENT OF ENVIRONMENTAL QUALITY ON COMPLETION.

- 24 THE FOLLOWING PROGRAMS AND ANY SIMILAR PROGRAMS CONDUCTED IN THIS
- 25 STATE:
- 26 (A) THE ADOPT-A-HIGHWAY PROGRAM ESTABLISHED BY THE STATE
- 27 TRANSPORTATION DEPARTMENT.

- 2 (C) THE ADOPT-A-RIVER PROGRAM ESTABLISHED UNDER PART 359.
- 3 (D) THE ADOPT-A-TRAIL PROGRAM ESTABLISHED UNDER SECTION
- 4 72105A.
- 5 (E) THE ADOPT-A-PARK PROGRAM ESTABLISHED UNDER SECTION 74104.
- 6 (2) BY DECEMBER 31 OF EACH YEAR, THE DEPARTMENT OF
- 7 ENVIRONMENTAL QUALITY SHALL PROVIDE A REPORT OF THE INFORMATION
- 8 COMPILED UNDER SUBSECTION (1) TO THE COMMITTEES OF BOTH HOUSES OF
- 9 THE LEGISLATURE WITH PRIMARY RESPONSIBILITY FOR MATTERS RELATING TO
- 10 NATURAL RESOURCES AND THE ENVIRONMENT, TO TRAVEL MICHIGAN, AND TO
- 11 THE RECYCLING ADVISORY COUNCIL CREATED UNDER SECTION 17403.
- 12 Enacting section 1. This amendatory act does not take effect
- 13 unless all of the following bills of the 94th Legislature are
- 14 enacted into law:
