A bill to amend 1980 PA 299, entitled "Occupational code,"

(MCL 339.101 to 339.2919) by amending the title, as amended by 1993 PA 93, and by adding section 1809a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 2 An act to revise, consolidate, and classify the laws of this

- 16 INCLUDE, BUT ARE NOT LIMITED TO, MAILING THE NOTICE TO THE LAST
- 17 KNOWN ADDRESS OF THAT PERSON. IF UNCLAIMED CREMATED REMAINS ARE
- 18 REMOVED FROM OR TRANSFERRED TO A CEMETERY, THE MORTUARY SCIENCE
- 19 LICENSEE SHALL PRESENT A WRITTEN STATEMENT TO THE CEMETERY
- 20 CERTIFYING COMPLIANCE WITH THE REQUIREMENTS IMPOSED IN THIS
- 21 SUBSECTION AT THE TIME THE UNCLAIMED CREMATED REMAINS ARE REMOVED

- 23 (2) [IN THE CASE OF UNCLAIMED CREMATED REMAINS DETERMINED TO BELONG TO A VETERAN,] A CEMETERY RELYING UPON A WRITTEN STATEMENT PRESENTED BY A
- 24 PERSON LICENSED IN THE PRACTICE OF MORTUARY SCIENCE UNDER
- 25 SUBSECTION (1) IS IMMUNE FROM CIVIL LIABILITY AGAINST A CLAIM FOR
- 26 DAMAGES BY THE PERSONS HAVING THE RIGHT TO MAKE DECISIONS RELATED
- 27 TO THE DISPOSITION OF A DECEDENT'S BODY UNDER SECTION 3206 OF THE

- 2 FOR HAVING INTERRED, ENTOMBED, OR INURNED CREMATED REMAINS WITHOUT

- 4 (3) THIS SECTION DOES NOT SUPERSEDE THE PROVISIONS OF SECTION
- 5 3206 OF THE ESTATES AND PROTECTED INDIVIDUALS CODE, 1998 PA 386,
- 6 MCL 700.3206, INVOLVING THE PRIORITY OF PERSONS HAVING THE RIGHT TO
- 7 MAKE DECISIONS RELATING TO THE DISPOSITION OF A DECEDENT'S BODY
- 8 UNDER THAT SECTION EXCEPT THAT IF THOSE PERSONS HAVING THE RIGHT TO
- 9 MAKE DECISIONS RELATED TO THE DISPOSITION OF A DECEDENT'S BODY
- 10 CLAIM THE CREMATED REMAINS AFTER PROPER DISPOSITION UNDER
- 11 SUBSECTION (1), THEN ANY COSTS ASSOCIATED WITH DISINTERRING OR

- 17 (A) "PROPER DISPOSITION" MEANS INTERMENT, ENTOMBMENT, OR
- 18 INURNMENT OF UNCLAIMED CREMATED REMAINS IN A CEMETERY IN THIS
- 19 STATE. IN THE CASE OF THE UNCLAIMED CREMATED REMAINS OF A VETERAN
- 20 OF THE UNITED STATES ARMED FORCES, PROPER DISPOSITION INCLUDES THE
- 21 INTERMENT, ENTOMBMENT, OR INURNMENT IN A CEMETERY DESIGNATED SOLELY
- 22 FOR VETERANS BY THE UNITED STATES DEPARTMENT OF VETERANS AFFAIRS OR
- 23 BY THE MICHIGAN DEPARTMENT OF VETERANS AFFAIRS.
- 24 (B) "UNCLAIMED CREMATED REMAINS" MEANS THE CREMATED REMAINS OF
- 25 A DEAD HUMAN BODY THAT HAS NOT BEEN PICKED UP OR DELIVERED TO A
- 26 PERSON HAVING THE RIGHT TO MAKE DECISIONS RELATING TO THE
- 27 DISPOSITION OF A DECEDENT'S BODY UNDER SECTION 3206 OF THE ESTATES
