THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 SEC. 4EE. A PERSON SUBJECT TO TAX UNDER THIS ACT MAY EXCLUDE 2 FROM THE GROSS PROCEEDS USED FOR THE COMPUTATION OF THIS TAX THE SALE OF A TEXTBOOK REQUIRED FOR TAKING A COURSE FOR CREDIT AT AN 3 4 INSTITUTION OF HIGHER EDUCATION IN THIS STATE. AS USED IN THIS 5 SECTION, "INSTITUTION OF HIGHER EDUCATION" MEANS A COLLEGE OR 6 UNIVERSITY LISTED IN SECTION 4 OR 5 OF ARTICLE VIII OF THE STATE 7 CONSTITUTION OF 1963 OR DESCRIBED IN SECTION 6 OF ARTICLE VIII OF 8 THE STATE CONSTITUTION OF 1963 OR A COMMUNITY OR JUNIOR COLLEGE 9 ESTABLISHED UNDER SECTION 7 OF ARTICLE VIII OF THE STATE 10 CONSTITUTION OF 1963.
