HOUSE BILL No. 4557

March 10, 2009, Introduced by Rep. Green and referred to the Committee on Regulatory Reform.

A bill to amend 1972 PA 382, entitled

"Traxler-McCauley-Law-Bowman bingo act,"

by amending section 3 (MCL 432.103), as amended by 2008 PA 401.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 3. As used in this act:

2 (a) "Educational organization" means an organization within

3 this state that is organized not for pecuniary profit, whose

4 primary purpose is educational in nature and designed to develop

5 the capabilities of individuals by instruction in any public or

6 private elementary or secondary school that complies with the

revised school code, 1976 PA 451, MCL 380.1 to 380.1852, or any

private or public college or university that is organized not for

pecuniary profit and that is approved by the state board of

education.

- 1 (b) "Fraternal organization" means an organization within this
- 2 state, except OTHER THAN a college fraternity or sorority, that is
- 3 MEETS ALL OF THE FOLLOWING CRITERIA:
- 4 (i) IS organized not for pecuniary profit. ; that is

- (f) "Person" means a natural person, firm, association,
- 19 corporation, or other legal entity.
- 20 (g) "Qualified organization" means, subject to subdivision
- 21 (h), either of the following:
- 22 (i) A bona fide religious, educational, service, senior
- 23 citizens, fraternal, or veterans' organization that operates
- 24 without profit to its members and that either has been in existence
- 25 continuously as an organization for a period of 5 years or is
- 26 exempt from taxation under 26 USC 501(c).

- 4 (h) "Qualified organization" does not include a candidate
- 5 committee, political committee, political party committee, ballot

- 7 as defined by, and organized under, the Michigan campaign finance
- 8 act, 1976 PA 388, MCL 169.201 to 169.282.
- 9 (i) "Religious organization" means any of the following:
- 10 (i) An organization, church, body of communicants, or group
- 11 that is organized not for pecuniary profit and that gathers in
- 12 common membership for mutual support and edification in piety,
- 13 worship, and religious observances.
- 14 (ii) A society of individuals that is organized not for
- 15 pecuniary profit and that unites for religious purposes at a
- 16 definite place.
- 17 (iii) A church related private school that is organized not for
- 18 pecuniary profit.
- 19 (j) "Senior citizens organization" means an organization
- 20 within this state that is organized not for pecuniary profit, that
- 21 consists of at least 15 members who are 60 years of age or older,
- 22 and that exists for their mutual support and for the advancement of
- 23 the causes of elderly or retired persons.
- (k) "Service organization" means either of the following:
- 25 (i) A branch, lodge, or chapter of a national or state
- 26 organization that is organized not for pecuniary profit and that is
- 27 authorized by its written constitution, charter, articles of

- 1 incorporation, or bylaws to engage in a fraternal, civic, or
- 2 service purpose within the state.
- 3 (ii) A local civic organization that is organized not for
- 4 pecuniary profit; that is not affiliated with a state or national
- 5 organization; that is recognized by resolution adopted by the local
- 6 governmental subdivision in which the organization conducts its
- 7 principal activities; whose constitution, charter, articles of
- 8 incorporation, or bylaws contain a provision for the perpetuation
- 9 of the organization as a nonprofit organization; whose entire
- 10 assets are used for charitable purposes; and whose constitution,
- 11 charter, articles of incorporation, or bylaws contain a provision
- 12 that all assets, real property, and personal property shall revert
- 13 to the benefit of the local governmental subdivision that granted
- 14 the resolution upon dissolution of the organization.
- 15 (l) "Veterans' organization" means an organization within this
- 16 state, or a branch, lodge, or chapter within this state of a state
- 17 organization or of a national organization chartered by the
- 18 congress of the United States, that is organized not for pecuniary
- 19 profit, the membership of which consists of individuals who were
- 20 members of the armed services or armed forces of the United States.
