THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

SEC. 11A. (1) IN A CIVIL ACTION BY A VICTIM OF IDENTITY THEFT
 AGAINST A PERSON THAT VIOLATES SECTION 5 OR 7, HE OR SHE MAY

3 RECOVER ALL OF THE FOLLOWING:

4 (A) HIS OR HER ACTUAL DAMAGES, REASONABLE ATTORNEY FEES, AND 5 COURT COSTS.

6 (B) REASONABLE REIMBURSEMENT FOR HIS OR HER TIME SPENT DOING
7 ANY OF THE FOLLOWING:

8 (*i*) NOTIFYING THIRD PARTIES THAT AN ACT OF IDENTITY THEFT HAS
9 OCCURRED.

5 (C) RESTITUTION, IN AN AMOUNT THAT COMPENSATES THE VICTIM IN 6 FULL FOR THE WORK DONE BY THE VICTIM OR THE VICTIM'S ATTORNEY, OR 7 BOTH, TO CORRECT THE VICTIM'S FINANCIAL RECORDS AND VITAL RECORDS 8 AND TO AMELIORATE THE EFFECTS OF THE IDENTITY THEFT ON THE VICTIM'S 9 FINANCIAL AFFAIRS, INCLUDING, BUT NOT LIMITED TO, HIS OR HER CREDIT 10 HISTORY, CREDIT RATING, OR CREDIT SCORE.

(2) FOR PURPOSES OF THIS SECTION, A PERSON THAT FAILS TO
COMPLY WITH THE PROVISIONS OF SECTION 5 OR 7 WHILE ACTING IN GOOD
FAITH IS NOT IN VIOLATION OF THAT SECTION IF THE COMPLIANCE FAILURE
WAS NOT INTENTIONAL AND RESULTED FROM A BONA FIDE ERROR
NOTWITHSTANDING THE MAINTENANCE OF PROCEDURES REASONABLY ADAPTED TO
AVOID THOSE ERRORS AND APPROPRIATE RESTITUTION IS MADE TO THE
VICTIM OF IDENTITY THEFT.

(3) AS USED IN THIS SECTION, A "BONA FIDE ERROR" INCLUDES, BUT
IS NOT LIMITED TO, A COMPUTER MALFUNCTION OR A CLERICAL,
CALCULATION, COMPUTER PROGRAMMING, OR PRINTING ERROR. AN ERROR OF
LEGAL JUDGMENT WITH RESPECT TO A PERSON'S OBLIGATIONS UNDER THIS
SECTION IS NOT A BONA FIDE ERROR.
