## **HOUSE BILL No. 5158**

June 25, 2009, Introduced by Reps. Meadows, Bledsoe, Warren, Liss, Smith, Valentine, Byrnes, Lipton, Miller, Roberts, Donigan, Slavens, Hammel, Barnett, Kennedy, Lisa Brown, Bauer, Robert Jones, Gonzales, Haugh and Coulouris and referred to the Committee on Judiciary.

A bill to require that crisis pregnancy organizations obtain informed consent from women served by those organizations; and to provide remedies and prescribe penalties.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1. As used in this act:
  - (a) "Crisis pregnancy organization" means a nongovernmental not-for-profit agency or organization that provides services and counseling to women who have unplanned or unwanted pregnancies.
    - (b) "Medically accurate" means verified or supported by research conducted in compliance with scientific methods and published in peer-review journals, where appropriate, and recognized as accurate and objective by professional organizations and agencies with relevant expertise in the field, such as the American college of obstetricians and gynecologists or the American gynecological and obstetrical society.

- 1 Sec. 2. Services shall not be provided to a pregnant woman by
- 2 any person who is employed by, a volunteer at, or in any manner
- 3 affiliated with a crisis pregnancy organization except with the
- 4 voluntary and informed consent of the pregnant woman. Consent to
- 5 the provision of services from a crisis pregnancy organization is
- 6 voluntary and informed only if all of the following conditions are
- 7 met, before any services are provided:
- 8 (a) A person employed by, a volunteer at, or in any manner
- 9 affiliated with the crisis pregnancy organization provides the
- 10 pregnant woman with the following information, orally and in
- 11 writing:
- 12 (i) A medically accurate and objective explanation of the full
- 13 range of options available to the pregnant woman regarding her
- 14 pregnancy, including abortion, parenting, and adoption.
- 15 (ii) Medically accurate and objective information on the range
- 16 of medical risks associated with abortion, pregnancy, and
- 17 childbirth.
- 18 (iii) That the pregnant woman has the right to obtain printed
- 19 materials listing medical clinics and hospitals that provide
- 20 abortion services.
- 21 (b) If the pregnant woman inquires about pregnancy
- 22 termination, abortion, or birth control services, a person employed
- 23 by, a volunteer at, or in any manner affiliated with the crisis
- 24 pregnancy organization orally or in writing informs the pregnant
- 25 woman that the crisis pregnancy organization does not provide
- 26 information on how to obtain an abortion, abortion services, or
- 27 birth control information.

- 1 (c) If the pregnant woman so requests, a person employed by, a
- 2 volunteer at, or in any manner affiliated with the crisis pregnancy
- 3 organization provides her with geographically indexed, printed
- 4 materials that contain a comprehensive list of the medical clinics
- 5 and hospitals that provide abortion services.
- 6 (d) The pregnant woman certifies in writing that the
- 7 information described in subdivision (a) has been provided to her
- 8 and that she has been informed of her right to review the printed
- 9 materials described in subdivision (c).
- 10 (e) A person employed by, a volunteer at, or in any manner

- 22 Sec. 3. A pregnant woman who receives services from a person
- 23 employed by, a volunteer at, or in any manner affiliated with a
- 24 crisis pregnancy organization who knowingly provided those services
- 25 in violation of this act may maintain an action against the crisis
- 26 pregnancy organization for actual and punitive damages.
