

# HOUSE BILL No. 5701

December 16, 2009, Introduced by Reps. Lahti, McDowell, Spade and Lindberg and referred to the Committee on Appropriations.

A bill to make, supplement, and adjust appropriations for certain capital outlay projects for the fiscal year ending September 30, 2010; to provide for the expenditure of the appropriations; and to prescribe certain conditions for the appropriations.

PART 2

PROVISIONS CONCERNING APPROPRIATIONS

GENERAL SECTIONS

7 Sec. 201. In accordance with the provisions of section 30 of  
8 article IX of the state constitution of 1963, total state spending  
9 from state resources in this appropriation act for the fiscal year  
10 ending September 30, 2010 is \$35,708,200.00. State appropriations  
11 paid to local units of government are \$22,903,800.00 as follows:

15 Sec. 202. The appropriations authorized under this act are  
16 subject to the management and budget act, 1984 PA 431, MCL 18.1101  
17 to 18.1594.

DEPARTMENT OF NATURAL RESOURCES

19 Sec. 301. The department of natural resources shall require  
20 local units of government to enter into agreements with the  
21 department of natural resources for the purpose of administering  
22 the natural resources trust fund grants identified in part 1. Among  
23 other provisions, the agreements shall require that grant  
24 recipients agree to dedicate to public outdoor recreation uses in



1 perpetuity the land acquired or developed; to replace lands  
2 converted or lost to other than public outdoor recreation use; and,  
3 for parcels acquired that are over 5 acres in size, to provide the  
4 state with a nonparticipating 1/6 minimum royalty interest in any  
5 acquired minerals that are retained by the grant recipient. The  
6 agreements shall also provide that the full payments of grants can  
7 be made only after proof of acquisition, or proof of completion of  
8 the development project, is submitted by the grant recipient and  
9 all costs are verified by the department of natural resources.

10       Sec. 302. Any unobligated balance in a natural resources trust  
11 fund appropriation made under part 1 shall not revert to the funds  
12 from which appropriated at the close of the fiscal year, but shall  
13 continue until the purpose for which it was appropriated is  
14 completed for a period not to exceed 3 fiscal years. The unexpended  
15 balance of any natural resources trust fund appropriation made in  
16 part 1 remaining after the purpose for which it was appropriated is  
17 completed shall revert to the Michigan natural resources trust fund  
18 and be made available for appropriation.
