

HOUSE BILL No. 6153

May 11, 2010, Introduced by Rep. Espinoza and referred to the Committee on Appropriations.

A bill to make, supplement, and adjust appropriations for the department of state police for the fiscal year ending September 30, 2010; to provide for the expenditure of the appropriations; and to prescribe certain conditions for the appropriations.

9 **GENERAL SECTIONS**

10 Sec. 201. In accordance with the provisions of section 30 of

11 article IX of the state constitution of 1963, total state spending

12 from state resources in this appropriation act for the fiscal year

13 ending September 30, 2010 is \$1,700,000.00 and state appropriations

14 paid to local units of government are \$0.

15 Sec. 202. The appropriations authorized under this act are

16 subject to the management and budget act, 1984 PA 431, MCL 18.1101

18 **INFORMATION TECHNOLOGY**

19 Sec. 301. The funds appropriated in part 1 shall be used

20 solely for the acquisition and deployment of a state integrated IP-

21 based 9-1-1 mapping system.
