

# SENATE BILL No. 1035

December 17, 2009, Introduced by Senator GARCIA and referred to the Committee on Appropriations.

A bill to amend 1935 PA 120, entitled

"An act to prescribe a method for the fingerprinting of residents of the state, and to provide for the recording and filing thereof by the central records division of the department of state police,"

by amending section 3 (MCL 28.273), as amended by 2007 PA 76.

**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

1           Sec. 3. (1) The department of state police may charge a fee,  
2 not to exceed \$30.00, until October 1, 2010, for taking and  
3 processing the fingerprints and completing a criminal record check  
4 of a resident of this state when the impression of the fingerprints  
5 are requested for employment-related or licensing-related purposes.  
6 A fee shall not be collected under this subsection if a fee for  
7 taking and processing fingerprints is collected under any other  
8 law. The fee shall not exceed the actual cost of taking and

1 processing the impression of the fingerprints and completing a  
2 criminal record check on that person. The fee shall be collected  
3 and forwarded to the state police by the licensing body or the  
4 employer.

5 (2) The department of state police shall submit a written  
6 report to the secretary of the senate and the clerk of the house of  
7 representatives by October 1 of each year stating whether the fee  
8 charged under subsection (1) is sufficient to support the actual  
9 costs of fingerprinting and what the actual costs of fingerprinting  
10 are.

11 (3) ~~Until October 1, 2010, the~~ **THE** department of state police  
12 may charge a fee of ~~\$10.00~~ **\$15.00** for processing and completing a  
13 name-based criminal record check. ~~A~~ **HOWEVER, A** fee shall not be  
14 charged under this subsection if a fee for processing the name-  
15 based criminal record check is charged under any other law  ~~-~~  
16 ~~However, a fee under this subsection shall not be charged in the~~  
17 ~~ease of~~ **OR IF THE REQUESTER IS** a government agency or nonprofit  
18 charitable agency performing employment or volunteer employment  
19 name-based background checks through the internet criminal history  
20 access tool (ICHAT). **FIVE DOLLARS OF EACH FEE COLLECTED UNDER THIS**  
21 **SUBSECTION, SUBJECT TO ANNUAL APPROPRIATION, SHALL BE USED BY THE**  
22 **DEPARTMENT OF STATE POLICE TO PAY SERVICE AND CONTRACT MAINTENANCE**  
23 **COSTS OF THE LAW ENFORCEMENT INFORMATION NETWORK.**

24 Enacting section 1. This amendatory act takes effect October  
25 1, 2010.
