

SENATE BILL No. 1314

April 29, 2010, Introduced by Senators NOFS, OLSHOVE, WHITMER, JACOBS, SWITALSKI, ANDERSON, HUNTER, GLEASON, BRATER, CHERRY, PRUSI, PATTERSON, BROWN and RICHARDVILLE and referred to the Committee on Judiciary.

A bill to amend 1927 PA 175, entitled
"The code of criminal procedure,"
by amending section 16d of chapter XVII (MCL 777.16d), as amended
by 2005 PA 336.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

CHAPTER XVII

Sec. 16d. This chapter applies to the following felonies
