SEC. 2977. (1) AN ACTION MAY BE BROUGHT BY OR ON BEHALF OF AN
 INDIVIDUAL INJURED BY A COERCIVE ACT. SUBJECT TO SUBSECTION (2), A
 PLAINTIFF IN AN ACTION UNDER THIS SECTION MAY RECOVER DAMAGES FOR
 EMOTIONAL DISTRESS AND OTHER DAMAGES ALLOWED BY LAW.

5 (2) IF THE DAMAGES AWARDED TO A PLAINTIFF IN AN ACTION UNDER 6 THIS SECTION FOR NONECONOMIC LOSS EXCEED \$5,000.00 AND DAMAGES 7 AWARDED TO THE PLAINTIFF IN THE ACTION FOR ECONOMIC LOSS ARE 8 \$5,000.00 OR LESS, THE AWARD FOR NONECONOMIC LOSS SHALL BE REDUCED 9 BY THE COURT TO \$5,000.00.

(3) A PERSON SHALL NOT BRING OR MAINTAIN AN ACTION UNDER THIS SECTION UNLESS THE ACTION IS COMMENCED WITHIN EITHER OF THE

13 (B) "ECONOMIC LOSS" MEANS THAT TERM AS DEFINED IN SECTION14 2945.

15 (C) "EMOTIONAL DISTRESS" MEANS SIGNIFICANT MENTAL SUFFERING OR
16 DISTRESS THAT MAY, BUT DOES NOT NECESSARILY, REQUIRE MEDICAL OR
17 OTHER PROFESSIONAL TREATMENT OR COUNSELING.

18 (D) "NONECONOMIC LOSS" MEANS THAT TERM AS DEFINED IN SECTION19 2945.

20 Enacting section 1. This amendatory act takes effect October21 1, 2012.

22 Enacting section 2. This amendatory act does not take effect
23 unless all of the following bills of the 96th Legislature are
24 enacted into law:
