February 24, 2011, Introduced by Reps. McCann, Smiley, Santana, Darany, Bauer, Slavens, Geiss, Townsend, Liss, Barnett, Tlaib, Hovey-Wright, Brown, Cavanagh, Dillon, Switalski, Segal, Durhal, Brunner, Rutledge, Meadows and Lipton and referred to the Committee on Families, Children, and Seniors.

A bill to amend 1939 PA 280, entitled "The social welfare act,"

by amending section 11 (MCL 400.11), as amended by 1990 PA 122.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 11. As used in this section and sections 11a to 11f:
- 2 (a) "Abuse" means harm or threatened harm to an adult's health
- 3 or welfare caused by another person. Abuse includes, but is not
- 4 limited to, nonaccidental physical or mental injury, sexual abuse,
 - FINANCIAL EXPLOITATION, or maltreatment.
 - (b) "Adult in need of protective services" or "adult" means a vulnerable person not less than 18 years of age who is suspected of being or believed to be abused, neglected, or exploited.
 - (C) "DECEPTION" MEANS THAT A PERSON KNOWINGLY DOES 1 OR MORE
 OF THE FOLLOWING TO AN INCAPACITATED OR VULNERABLE ADULT:

- 1 (i) CREATE OR CONFIRM A FALSE IMPRESSION IN AN INCAPACITATED OR
- 2 VULNERABLE ADULT'S MIND.
- 3 (ii) FAIL TO CORRECT A FALSE IMPRESSION THAT THE PERSON IS
- 4 RESPONSIBLE FOR CREATING OR CONFIRMING IN AN INCAPACITATED OR

- 19 (D) (e) "Exploitation" means an action that involves the
- 20 misuse of an adult's funds, property, or personal dignity, OR
- 21 FINANCIAL EXPLOITATION by another person.
- 22 (E) "FINANCIAL EXPLOITATION" MEANS THE ACTION OF A PERSON IN A
- 23 POSITION OF TRUST AND CONFIDENCE AND WHO BY INTIMIDATION OR
- 24 DECEPTION KNOWINGLY TAKES CONTROL, TITLE, USE, OR MANAGEMENT OF AN
- 25 INCAPACITATED OR VULNERABLE ADULT'S ASSETS OR PROPERTY WITH THE
- 26 INTENT TO PERMANENTLY DEPRIVE THAT INCAPACITATED OR VULNERABLE
- 27 ADULT OF HIS OR HER ASSET OR PROPERTY.

- 1 (F) "FINANCIAL INSTITUTION" MEANS A STATE OR NATIONALLY
- 2 CHARTERED BANK OR A STATE OR FEDERALLY CHARTERED SAVINGS AND LOAN

- 12 situation or by the conduct of a person who assumes responsibility
- 13 for a significant aspect of the adult's health or welfare. Neglect
- 14 includes the failure to provide adequate food, clothing, shelter,
- 15 or medical care. A person shall not be considered to be abused,
- 16 neglected, or in need of emergency or protective services for the
- 17 sole reason that the person is receiving or relying upon treatment
- 18 by spiritual means through prayer alone in accordance with the
- 19 tenets and practices of a recognized church or religious
- 20 denomination, and this act shall not require any medical care or
- 21 treatment in contravention of the stated or implied objection of
- 22 that person.
- 23 (I) "PERSON" MEANS AN INDIVIDUAL, PARTNERSHIP, CORPORATION,
