## **HOUSE BILL No. 5181**

November 29, 2011, Introduced by Rep. O'Brien and referred to the Committee on Families, Children, and Seniors.

A bill to amend 1961 PA 236, entitled "Revised judicature act of 1961,"

(MCL 600.101 to 600.9947) by adding section 2977.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 2977. (1) AN ACTION MAY BE BROUGHT BY OR ON BEHALF OF AN
- 2 INDIVIDUAL INJURED BY A COERCIVE ACT. SUBJECT TO SUBSECTION (2), A
- 3 PLAINTIFF IN AN ACTION UNDER THIS SECTION MAY RECOVER DAMAGES FOR
- 4 EMOTIONAL DISTRESS AND OTHER DAMAGES ALLOWED BY LAW.
- 5 (2) IF THE DAMAGES AWARDED TO A PLAINTIFF IN AN ACTION UNDER
- 6 THIS SECTION FOR NONECONOMIC LOSS EXCEED \$5,000.00 AND DAMAGES
- 7 AWARDED TO THE PLAINTIFF IN THE ACTION FOR ECONOMIC LOSS ARE
- 8 \$5,000.00 OR LESS, THE AWARD FOR NONECONOMIC LOSS SHALL BE REDUCED
- 9 BY THE COURT TO \$5,000.00.
  - (3) A PERSON SHALL NOT BRING OR MAINTAIN AN ACTION UNDER THIS
    - SECTION UNLESS THE ACTION IS COMMENCED WITHIN EITHER OF THE

- 2 (A) THREE YEARS AFTER THE CLAIM FIRST ACCRUES TO THE

- 5 18 YEARS OF AGE AT THE TIME THE CLAIM FIRST ACCRUES, 1 YEAR AFTER

- 7 (4) THIS SECTION DOES NOT CREATE A RIGHT TO ABORTION.
- 8 NOTWITHSTANDING ANY PROVISION OF THIS SECTION, A PERSON SHALL NOT

- 13 (B) "ECONOMIC LOSS" MEANS THAT TERM AS DEFINED IN SECTION
- 14 2945.
- 15 (C) "EMOTIONAL DISTRESS" MEANS SIGNIFICANT MENTAL SUFFERING OR
- 16 DISTRESS THAT MAY, BUT DOES NOT NECESSARILY, REQUIRE MEDICAL OR
- 17 OTHER PROFESSIONAL TREATMENT OR COUNSELING.
- 18 (D) "NONECONOMIC LOSS" MEANS THAT TERM AS DEFINED IN SECTION
- 19 2945.
- 20 Enacting section 1. This amendatory act takes effect October
- **21** 1, 2012.
- 22 Enacting section 2. This amendatory act does not take effect
