A bill to amend 1931 PA 328, entitled "The Michigan penal code,"

(MCL 750.1 to 750.568) by adding section 411x.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 411X. (1) A PERSON SHALL NOT BULLY OR CYBERBULLY ANOTHER
 2 PERSON.
- 3 (2) A PERSON WHO VIOLATES THIS SECTION IS GUILTY OF A
- 4 MISDEMEANOR PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 93 DAYS OR
- 5 A FINE OF NOT MORE THAN \$1,000.00, OR BOTH.
- 6 (3) THE COURT MAY ORDER A PERSON CONVICTED OF OR FOUND
- 7 RESPONSIBLE FOR A VIOLATION OF THIS SECTION TO UNDERGO AN
- 8 EVALUATION BY A MENTAL HEALTH PROFESSIONAL AT HIS OR HER OWN
- 9 EXPENSE AND TO RECEIVE COUNSELING OR OTHER TREATMENT AT HIS OR HER
- 10 OWN EXPENSE IF DETERMINED APPROPRIATE BY THE COURT.

- 9 PRESENCE WITH A DEROGATORY OR OFFENSIVE NICKNAME OR LABEL.
- 10 (iii) DISSEMINATING FALSE OR MISLEADING INFORMATION ABOUT THAT

- 12 (B) "CYBERBULLY" MEANS TO BULLY THROUGH THE USE OF A COMPUTER,
- 13 COMPUTER NETWORK, COMPUTER PROGRAM, OR COMPUTER SYSTEM, AS THOSE
- 14 TERMS ARE DEFINED IN SECTION 145D, OR THROUGH THE USE OF A SERVICE
- 15 PROVIDED BY A TELECOMMUNICATIONS PROVIDER.
- 16 (C) "MENTAL HEALTH PROFESSIONAL" MEANS THAT TERM AS DEFINED IN
- 17 SECTION 100B OF THE MENTAL HEALTH CODE, 1974 PA 258, MCL 330.1100B.
