

SENATE SUBSTITUTE FOR
HOUSE BILL NO. 4711

A bill to amend 1998 PA 58, entitled
"Michigan liquor control code of 1998,"
by amending section 411 (MCL 436.1411), as amended by 2011 PA 298.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 411. (1) A brewer that is not licensed as a micro brewer
2 may sell its beer for on-premises consumption at not more than $\pm$
3 ~~location~~ **2 LOCATIONS** in this state that ~~is~~ **ARE** on any of its
4 licensed brewery premises **WHERE THE BREWER ENGAGES IN THE**
5 **PRODUCTION OF BEER. A LICENSED MICRO BREWER THAT PRODUCES IN TOTAL**
6 **FEWER THAN 30,000 BARRELS OF BEER PER YEAR MAY SELL ITS BEER FOR**
7 **ON-PREMISES CONSUMPTION AT ANY LOCATION IN THIS STATE THAT IS ON**
8 **ANY OF ITS LICENSED BREWERY PREMISES WHERE THE MICRO BREWER ENGAGES**
9 **IN THE PRODUCTION OF BEER. A LICENSED MICRO BREWER THAT PRODUCES IN**

1 TOTAL 30,000 BARRELS OF BEER OR MORE PER YEAR MAY SELL ITS BEER FOR
2 ON-PREMISES CONSUMPTION AT NOT MORE THAN 3 LOCATIONS IN THIS STATE
3 THAT ARE ON ANY OF ITS LICENSED BREWERY PREMISES WHERE THE MICRO
4 BREWER ENGAGES IN THE PRODUCTION OF BEER.

5 (2) SUBJECT TO THE LIMITATIONS IN SUBSECTION (1), IF A BREWER
6 OR MICRO BREWER HAS MORE THAN 1 LICENSED BREWERY PREMISES, THAT
7 BREWER OR MICRO BREWER MAY SELL FOR ON-PREMISES CONSUMPTION BEER
8 THAT IT HAS PRODUCED AT 1 LICENSED BREWERY PREMISES AT ANY OF ITS
9 OTHER LICENSED BREWERY PREMISES.

10 (3) AS USED IN THIS SECTION, "ENGAGES IN THE PRODUCTION OF
11 BEER" MEANS THE FULL AND COMPLETE BREWING PROCESS AND NOT JUST A
12 PORTION OF THE BREWING PROCESS.

13 Enacting section 1. This amendatory act does not take effect
14 unless all of the following bills of the 97th Legislature are
15 enacted into law:
