**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

1       Sec. 213. (1) If a person has not previously been denied a  
2 license or a certificate of registration or had a license or a  
3 certificate of registration revoked or suspended, the department  
4 may grant a nonrenewable temporary license or certificate of  
5 registration to an applicant for licensure or registration or  
6 transfer of licensure or registration ~~pursuant to~~ **UNDER ANY OF**  
7 articles ~~8-7~~ to ~~25-29~~.

1 valid until 1 or more of the following occurs:

2 (a) The results of the next scheduled examination are  
3 available.

4 (b) The results of the next required evaluation procedure are  
5 available.

6 (c) A license or certificate of registration is issued.

7 (d) The next examination date of an examination for licensure  
8 or registration in the applicable occupation, if the applicant does  
9 not take the examination.

10 (e) The applicant fails to meet the requirements for a license  
11 or certificate of registration.

12 (f) A change in employment is made.

13 (2) IN ADDITION TO A TEMPORARY LICENSE OR CERTIFICATE OF  
14 REGISTRATION UNDER SUBSECTION (1), BEGINNING 90 DAYS AFTER THE  
15 EFFECTIVE DATE OF THE AMENDATORY ACT THAT ADDED THIS SUBSECTION,  
16 THE DEPARTMENT SHALL GRANT A TEMPORARY LICENSE OR CERTIFICATE OF  
17 REGISTRATION FOR AN OCCUPATION UNDER THIS ACT TO AN APPLICANT WHO  
18 MEETS ALL OF THE FOLLOWING:

19 (A) HE OR SHE PROVIDES PROOF ACCEPTABLE TO THE DEPARTMENT THAT  
20 HE OR SHE IS MARRIED TO A MEMBER OF THE ARMED FORCES WHO IS ON  
21 ACTIVE DUTY. AS USED IN THIS SUBDIVISION, "ARMED FORCES" MEANS THAT  
22 TERM AS DEFINED IN SECTION 2 OF THE VETERAN RIGHT TO EMPLOYMENT  
23 SERVICES ACT, 1994 PA 39, MCL 35.1092.

24 (B) HE OR SHE PROVIDES PROOF ACCEPTABLE TO THE DEPARTMENT THAT  
25 HE OR SHE HOLDS A CURRENT LICENSE IN GOOD STANDING<<, >> OR A CURRENT  
26 REGISTRATION <<IN GOOD STANDING, >> IN THAT OCCUPATION<<, >> ISSUED BY  
27 AN EQUIVALENT LICENSING DEPARTMENT, BOARD, OR AUTHORITY, AS DETERMINED BY THE DEPARTMENT,

1 IN ANOTHER STATE OF THE UNITED STATES, THE DISTRICT OF COLUMBIA,  
2 PUERTO RICO, THE UNITED STATES VIRGIN ISLANDS, ANOTHER TERRITORY OR  
3 PROTECTORATE OF THE UNITED STATES, OR A FOREIGN COUNTRY.

4 (C) HE OR SHE PROVIDES PROOF ACCEPTABLE TO THE DEPARTMENT THAT  
5 HIS OR HER SPOUSE IS ASSIGNED TO A DUTY STATION IN THIS STATE AND  
6 THAT HE OR SHE IS ALSO ASSIGNED TO A DUTY STATION IN THIS STATE  
7 UNDER HIS OR HER SPOUSE'S <<PERMANENT CHANGE OF STATION ORDERS>>.

8 (3) A TEMPORARY LICENSE OR REGISTRATION ISSUED UNDER  
9 SUBSECTION (2) IS VALID FOR 6 MONTHS AND MAY BE RENEWED FOR 1  
10 ADDITIONAL 6-MONTH TERM IF THE DEPARTMENT DETERMINES THE TEMPORARY  
11 LICENSEE OR REGISTRANT CONTINUES TO MEET THE REQUIREMENTS OF  
12 SUBSECTION (2) AND NEEDS ADDITIONAL TIME TO FULFILL THE  
13 REQUIREMENTS FOR INITIAL LICENSURE OR REGISTRATION IN THIS STATE.  
14 ~~————(3) A THE DEPARTMENT MAY PLACE A LIMITATION ON A temporary~~  
15 ~~license or certificate of registration may be limited as defined in~~  
16 ~~article 1. GRANTED UNDER THIS SECTION.~~
