

# HOUSE BILL No. 5204

December 12, 2013, Introduced by Reps. A bill to amend 1984 PA 431, entitled  
"The management and budget act,"  
by amending section 267 (MCL 18.1267), as amended by 2012 PA 237.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1       Sec. 267. (1) The department shall issue directives to provide  
2       for the disclosure, transfer, and disposal of surplus personal  
3       property of state agencies. ~~The~~**EXCEPT AS OTHERWISE PROVIDED IN**  
4       **SUBSECTION (4),** THE department may dispose of surplus personal  
5       property by donating the surplus personal property to a nonprofit  
6       entity, or selling it to a unit of local government, or selling it  
7       at a public sale.

8       (2) The department may sell surplus personal property at fair  
9       market value. The department may also exchange surplus personal

1 property for goods and services at fair market value with a private  
2 company that is contracted to provide state services, and the  
3 surplus personal property is essential to providing those services.

4 (3) The department may pay necessary costs incurred in the  
5 conduct of the transfers or sale of surplus personal property  
6 including the necessary warehousing and reconditioning costs from  
7 the proceeds of the sale or by assessing a handling fee for surplus  
8 personal property being donated.

9 (4) BEGINNING JUNE 1, 2014, PRIOR TO DONATING, DISPOSING OF,  
10 OR SELLING SURPLUS SNOW REMOVAL EQUIPMENT THAT WAS OWNED OR  
11 OPERATED BY THE STATE TRANSPORTATION DEPARTMENT, THE STATE  
12 TRANSPORTATION DEPARTMENT SHALL MAKE THAT SNOW REMOVAL EQUIPMENT  
13 AVAILABLE FOR SALE TO LOCAL UNITS OF GOVERNMENT IN THIS STATE. THE  
14 DEPARTMENT SHALL ISSUE DIRECTIVES TO IMPLEMENT THIS SUBSECTION.
