- 15 (e) "Security interest" means any interest in real or personal
- 16 property that secures payment or performance of an obligation.
- 17 (f) "Substituted proceeds of a crime" means any property
- 18 obtained or any gain realized by the sale or exchange of proceeds
- 19 of a crime.
- 20 Enacting section 1. This amendatory act takes effect 90 days
- 21 after the date it is enacted into law.
- 22 Enacting section 2. This amendatory act does not take effect
- 23 unless House Bill No. 5234 of the 97th Legislature is enacted into
- 24 law.
