## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 8C. IN ADDITION TO THE SPECIFIC POLICY DESCRIBED IN
- 2 SECTIONS 8B AND 8D, THE DEPARTMENT SHALL DRAFT AND MAINTAIN A
- 3 SPECIFIC POLICY FOR FOSTER CHILDREN AS PROVIDED IN THIS SECTION.
- 4 THIS SPECIFIC POLICY SHALL BE IMPLEMENTED BY NO LATER THAN JULY 1,
- 5 2015 AND SHALL, IN ADDITION TO THE PROVISIONS OF SECTIONS 8B AND
- 6 8D, ADDRESS THE FOSTER CHILD'S ACCESS TO THE FOLLOWING AS AGE-
  - APPROPRIATE AND AS MANDATED BY THE COURT:
- 8 (A) REGULAR CONTACT WITH ALL OF THE FOSTER CHILD'S
- 9 CASEWORKERS, ATTORNEYS, AND ADVOCATES.
  - (B) RELEVANT INFORMATION REGARDING A CHANGE IN THE FOSTER
