PART 2

PROVISIONS CONCERNING APPROPRIATIONS

FOR FISCAL YEAR 2015-2016

**GENERAL SECTIONS**

Sec. 201. In accordance with the provisions of section 30 of article IX of the state constitution of 1963, total state spending from state resources in this appropriation act for the fiscal year ending September 30, 2016 is \$25,183,500.00 and state appropriations paid to local units of government are \$8,963,500.00.

Sec. 202. The appropriations made and expenditures authorized under this act and the departments, commissions, boards, offices, and programs for which appropriations are made under this act are subject to the management and budget act, 1984 PA 431, MCL 18.1101 to 18.1594.

<<Sec. 203. The office of the auditor general shall audit the use of the funds appropriated in part 1 and report to the chairs of the senate and house appropriations committees at a minimum of every six months until the funds are expended. All relevant records associated with the funds appropriated in part 1 shall be made available to the office of the auditor general upon request.>>

**DEPARTMENT OF EDUCATION**

Sec. 301. From the funds appropriated in section 102 for the Flint declaration of emergency, the department of education shall allocate funds to address needs related to the declaration of emergency issued on January 5, 2016. These funds shall be used to support the following activities:

(a) Hiring additional school nurses.

(b) In the intermediate school district in which the declaration of emergency has been made, providing early on and special education services, monitoring children from age 0 to 3 for symptoms of potential lead exposure, coordinating wraparound services, providing nutritional snacks to elementary students, and

1 providing and coordinating communications for parents, educators,  
2 and the community.

3 **DEPARTMENT OF ENVIRONMENTAL QUALITY**

4 Sec. 401. From the funds appropriated in section 103 for the  
5 Flint declaration of emergency, the department of environmental  
6 quality shall allocate funds to address needs related to the  
7 declaration of emergency issued on January 5, 2016. These funds  
8 shall be used to support the following activities:

9 (a) Water system needs.

10 (b) Potential payment to city of Flint to aid with utility  
11 issues.

12 (c) Lab and testing costs.

13 (d) Corrosion control procedures.

14 (e) Infrastructure integrity study using outside experts.

15 **DEPARTMENT OF HEALTH AND HUMAN SERVICES**

16 Sec. 501. From the funds appropriated in section 104 for the  
17 Flint declaration of emergency, the department of health and human  
18 services shall allocate funds to address needs related to the  
19 declaration of emergency issued on January 5, 2016. These funds  
20 shall be used to support the following activities:

21 (a) Purchases of bottled water, water filters, and replacement  
22 filter cartridges.

23 (b) Department field operations costs.

24 (c) Epidemiological analysis and case management of  
25 individuals at risk of elevated blood lead levels.



(d) Nutrition support, food banks, and community education.

(e) Support for child and adolescent health centers and children's health care access program.

(f) Assessment of potential linkages to other diseases.

(g) Food inspections.

(h) Crisis counseling and behavioral health services.

(i) Additional nurse services.

#### **DEPARTMENT OF LICENSING AND REGULATORY AFFAIRS**

Sec. 601. From the funds appropriated in section 105 for the Flint declaration of emergency, the department of licensing and regulatory affairs shall allocate funds to address needs related to the declaration of emergency issued on January 5, 2016. These funds shall be used to support plumbing fixture replacements at facilities to be designated by the department of licensing and regulatory affairs.

#### **DEPARTMENT OF MILITARY AND VETERANS AFFAIRS**

Sec. 701. From the funds appropriated in section 106 for the Flint declaration of emergency, the department of military and veterans affairs shall allocate funds to address needs related to the declaration of emergency issued on January 5, 2016. These funds shall be used to support the Michigan National Guard water support efforts.

#### **DEPARTMENT OF STATE POLICE**

Sec. 801. From the funds appropriated in section 107 for the

1 Flint declaration of emergency, the department of state police  
2 shall allocate funds to address needs related to the declaration of  
3 emergency issued on January 5, 2016. These funds shall be used to  
4 support operational funding for the Flint water interagency  
5 coordinating committee.
