1 (2) AN ORDER ISSUED UNDER SUBSECTION (1) MUST LIST THE NAME 2 AND BILLING TELEPHONE NUMBER OF THE NAMED CUSTOMER, THE NAME AND 3 TELEPHONE NUMBER OF THE PETITIONER, AND EACH TELEPHONE NUMBER TO BE 4 TRANSFERRED TO THE PETITIONER. THE COURT SHALL ENSURE THAT THE 5 CONTACT INFORMATION OF THE PETITIONER IS NOT PROVIDED TO THE 6 CUSTOMER OR RESPONDENT.
