- 1 SEC. 3406T. (1) AN EXPENSE-INCURRED HOSPITAL, MEDICAL, OR
- 2 SURGICAL GROUP OR INDIVIDUAL POLICY OR CERTIFICATE DELIVERED,
- 3 ISSUED FOR DELIVERY, OR RENEWED IN THIS STATE AND A HEALTH
- 4 MAINTENANCE ORGANIZATION GROUP OR INDIVIDUAL CONTRACT SHALL PROVIDE
- 5 BENEFITS FOR CRANIAL HAIR PROSTHESIS FOR AN INDIVIDUAL WHO IS LESS
- 6 THAN 19 YEARS OF AGE AND HAS CRANIAL HAIR LOSS AS A RESULT OF A
- 7 MEDICAL CONDITION OR AS A RESULT OF TREATMENT FOR A MEDICAL
- 8 CONDITION.
- 9 (2) THE COVERAGE REQUIRED BY THIS SECTION IS NOT SUBJECT TO
- 10 DOLLAR LIMITS, DEDUCTIBLES, AND COINSURANCE PROVISIONS THAT ARE
- 11 LESS FAVORABLE THAN THOSE FOR OTHER PROSTHESIS COVERAGE.

- 1 (3) AS USED IN THIS SECTION, "CRANIAL HAIR PROSTHESIS"
- 2 INCLUDES ANY HUMAN OR SYNTHETIC SUBSTITUTES FOR CRANIAL HAIR.
- 3 Enacting section 1. This amendatory act takes effect 90 days
- 4 after the date it is enacted into law.
- 5 Enacting section 2. This amendatory act applies to policies,
- 6 certificates, and contracts delivered, executed, issued, amended,
- 7 adjusted, or renewed in this state, or outside of this state if
- 8 covering residents of this state, beginning 90 days after the date
- 9 this amendatory act is enacted into law.
