HOUSE BILL No. 4772

July 14, 2015, Introduced by Rep. Gamrat and referred to the Committee on Judiciary.

A bill to amend 1931 PA 328, entitled "The Michigan penal code,"

by amending section 237a (MCL 750.237a), as amended by 2015 PA 26; and to repeal acts and parts of acts.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 237a. (1) An individual who engages in conduct proscribed
- 2 under section 224, 224a, 224b, 224c, 224e, 226, 227, 227a, 227f,
- 3 234a, 234b, or 234c , or who engages in conduct proscribed under
- 4 section 223(2) for a second or subsequent time, in a weapon free
- 5 school zone is guilty of a felony punishable by 1 or more of the6 following:
 - (a) Imprisonment for not more than the maximum term of imprisonment authorized for the section violated.
 - (b) Community service for not more than 150 hours.
 - (c) A fine of not more than 3 times the maximum fine

- 1 authorized for the section violated.
- 2 (2) An individual who engages in conduct proscribed under
- 3 section 223(1), 224d, 226a, 227c, 227d, 231c, 232a(1) or (4), 233,
- 4 234, 234e, 234f, 235, 236, or 237 , or who engages in conduct
- 5 proscribed under section 223(2) for the first time, in a weapon
- 6 free school zone is guilty of a misdemeanor punishable by 1 or more
- 7 of the following:
- 8 (a) Imprisonment for not more than the maximum term of
- 9 imprisonment authorized for the section violated or 93 days,
- 10 whichever is greater.
- (b) Community service for not more than 100 hours.
- 12 (c) A fine of not more than \$2,000.00 or the maximum fine
- 13 authorized for the section violated, whichever is greater.
- 14 (3) Subsections (1) and (2) do not apply to conduct proscribed
- 15 under a section enumerated in those subsections to the extent that
- 16 the proscribed conduct is otherwise exempted or authorized under
- 17 this chapter.
- 18 (4) Except as provided in subsection (5), an individual who
- 19 possesses a weapon in a weapon free school zone is guilty of a
- 20 misdemeanor punishable by 1 or more of the following:
- 21 (a) Imprisonment for not more than 93 days.
- (b) Community service for not more than 100 hours.
- 23 (c) A fine of not more than \$2,000.00.
- 24 (5) Subsection (4) does not apply to any of the following:
- 25 (a) An individual employed by or contracted by a school if the
- 26 possession of that weapon is to provide security services for the
- 27 school.

- 1 (b) A peace officer.
- 2 (c) An individual licensed by this state or another state to
- 3 carry a concealed weapon.
- 4 (d) An individual who possesses a weapon provided by a school
- 5 or a school's instructor on school property for purposes of
- 6 providing or receiving instruction in the use of that weapon.
- 7 (e) An individual who possesses a firearm on school property
- 8 if that possession is with the permission of the school's principal
- 9 or an agent of the school designated by the school's principal or
- 10 the school board.
- 11 (f) An individual who is 18 years of age or older who is not a
- 12 student at the school and who possesses a firearm on school
- 13 property while transporting a student to or from the school if any
- 14 of the following apply:
- 15 (i) The individual is carrying an antique firearm, completely
- 16 unloaded, in a wrapper or container in the trunk of a vehicle while
- 17 en route to or from a hunting or target shooting area or function
- 18 involving the exhibition, demonstration or sale of antique
- 19 firearms.
- 20 (ii) The individual is carrying a firearm unloaded in a
- 21 wrapper or container in the trunk of the person's vehicle, while in
- 22 possession of a valid Michigan hunting license or proof of valid
- 23 membership in an organization having shooting range facilities, and
- 24 while en route to or from a hunting or target shooting area.
- 25 (iii) The person is carrying a firearm unloaded in a wrapper
- 26 or container in the trunk of the person's vehicle from the place of
- 27 purchase to his or her home or place of business or to a place of

- 1 repair or back to his or her home or place of business, or in
- 2 moving goods from one place of abode or business to another place
- 3 of abode or business.
- 4 (iv) The person is carrying an unloaded firearm in the
- 5 passenger compartment of a vehicle that does not have a trunk, if
- 6 the person is otherwise complying with the requirements of
- 7 subparagraph (ii) or (iii) and the wrapper or container is not
- 8 readily accessible to the occupants of the vehicle.
- 9 (6) As used in this section:
- 10 (a) "Antique firearm" means either of the following:
- 11 (i) A firearm not designed or redesigned for using rimfire or
- 12 conventional center fire ignition with fixed ammunition and
- 13 manufactured in or before 1898, including a matchlock, flintlock,
- 14 percussion cap, or similar type of ignition system or a replica of
- 15 such a firearm, whether actually manufactured before or after the
- **16** year 1898.
- 17 (ii) A firearm using fixed ammunition manufactured in or
- 18 before 1898, for which ammunition is no longer manufactured in the
- 19 United States and is not readily available in the ordinary channels
- 20 of commercial trade.
- 21 (b) "School" means a public, private, denominational, or
- 22 parochial school offering developmental kindergarten, kindergarten,
- 23 or any grade from 1 through 12.
- 24 (c) "School property" means a building, playing field, or
- 25 property used for school purposes to impart instruction to children
- 26 or used for functions and events sponsored by a school, except a
- 27 building used primarily for adult education or college extension

- 1 courses.
- 2 (d) "Weapon" includes, but is not limited to, a pneumatic gun.
- 3 (e) "Weapon free school zone" means school property and a
- 4 vehicle used by a school to transport students to or from school
- 5 property.
- 6 Enacting section 1. Sections 223, 227, 227a, 227c, 227d, 228,
- 7 231, 231a, 232a, and 234d of the Michigan penal code, 1931 PA 328,
- 8 MCL 750.223, 750.227, 750.227a, 750.227c, 750.227d, 750.228,
- 9 750.231, 750.231a, 750.232a, and 750.234d, are repealed.
