## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 110A. (1) THE DEPARTMENT SHALL AUTHORIZE CONTRACTED
- 2 HEALTH PLANS TO ENTER INTO AGREEMENTS WITH CLINICS TO PROVIDE
- 3 MEDICAL ASSISTANCE RECIPIENTS WITH AN ALTERNATIVE TO EMERGENCY
- 4 DEPARTMENT VISITS FOR MEDICALLY NECESSARY AND REASONABLE
- 5 NONEMERGENCY HEALTH CARE.
- 6 (2) THE DEPARTMENT SHALL CREATE A PILOT PROGRAM TO IMPLEMENT
- 7 THE PROVISIONS OF THIS SECTION.
- 8 (3) THE PROGRAM CREATED UNDER THIS SECTION SHOULD INCLUDE
- VOUCHERS FOR THE MEDICAL ASSISTANCE RECIPIENT TO PROVIDE TO THE

- 1 CLINIC UPON SEEKING NONEMERGENCY HEALTH CARE TREATMENT.
- 2 (4) AS USED IN THIS SECTION:
- 3 (A) "CLINIC" INCLUDES, BUT IS NOT LIMITED TO, A WALK-IN
- 4 CLINIC, A CLINIC LOCATED IN A RETAIL STORE, AN URGENT CARE CLINIC,
- 5 AND A PEDIATRIC URGENT CARE CLINIC.
- 6 (B) "MEDICAL EMERGENCY" MEANS A CONDITION FOR WHICH A DELAY IN
- 7 TREATMENT MAY RESULT IN THE MEDICAL ASSISTANCE RECIPIENT'S DEATH OR
- 8 PERMANENT IMPAIRMENT OF THE MEDICAL ASSISTANCE RECIPIENT'S HEALTH.
- 9 (C) "NONEMERGENCY HEALTH CARE" MEANS CARE FOR A CONDITION THAT

- 11 (D) "PSYCHIATRIC EMERGENCY" MEANS A CONDITION THAT MUST BE
- 12 IMMEDIATELY TREATED TO PREVENT SERIOUS INJURY TO THE MEDICAL
- 13 ASSISTANCE RECIPIENT OR TO ANOTHER INDIVIDUAL.
- 14 Enacting section 1. This amendatory act takes effect 90 days
- 15 after the date it is enacted into law.
