THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

SEC. 496A. (1) A PERSON MAY PREREGISTER TO VOTE AT A SECRETARY 1 2 OF STATE OFFICE IF HE OR SHE MEETS ALL OF THE FOLLOWING

3 **REQUIREMENTS:**

4 (A) IS AT LEAST 16 YEARS OF AGE BUT LESS THAN 17-1/2 YEARS OF 5 AGE.

6 (B) HAS BEEN ISSUED EITHER A GRADUATED LICENSING STATUS TO OPERATE A MOTOR VEHICLE UNDER SECTION 310E OF THE MICHIGAN VEHICLE 7 CODE, 1949 PA 300, MCL 257.310E, OR AN OFFICIAL STATE PERSONAL 8 9 IDENTIFICATION CARD UNDER 1972 PA 222, MCL 28.291 TO 28.300.

(C) IS A CITIZEN OF THE UNITED STATES.

(2) THE SECRETARY OF STATE IS AUTHORIZED TO CREATE A

THE PREREGISTRATION TO 11 12 VOTE APPLICATION SHALL BE HELD IN A SEPARATE FILE AND SHALL NOT BE MOVED TO THE MASTER FILE UNTIL THE PERSON WHO FILED THE 13 PREREGISTRATION TO VOTE APPLICATION BECOMES 17-1/2 YEARS OF AGE. 14

15 (5) THE QUALIFIED VOTER FILE SHALL NOT INCLUDE THE NAME OF A
16 PERSON WHO PREREGISTERS TO VOTE ON A PRECINCT VOTER LIST BEFORE THE

(6) IF A PERSON WHO PREREGISTERS TO VOTE CHANGES THE ADDRESS
THAT APPEARS ON HIS OR HER DRIVER LICENSE OR PERSONAL
IDENTIFICATION CARD, THE PREREGISTRATION TO VOTE ADDRESS FOR THAT
PERSON SHALL ALSO BE CHANGED.

(7) WHEN A PERSON WHO PREREGISTERS TO VOTE BECOMES 17-1/2
YEARS OF AGE, THE SECRETARY OF STATE SHALL SEND A NOTICE THROUGH
THE QUALIFIED VOTER FILE TO THE APPROPRIATE CITY OR TOWNSHIP CLERK
DIRECTING THE CLERK TO SEND A VOTER IDENTIFICATION CARD TO THE
PERSON WHO PREREGISTERED TO VOTE.
