

SUBSTITUTE FOR  
HOUSE BILL NO. 4679

A bill to amend 1986 PA 268, entitled  
"Legislative council act,"  
(MCL 4.1101 to 4.1901) by adding sections 502 and 602.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1           SEC. 502. (1) THE SENATE FISCAL AGENCY SHALL PREPARE, FOR EACH  
2 BILL THAT IS SCHEDULED FOR A HEARING BEFORE A STANDING COMMITTEE OF  
3 THE SENATE, A FISCAL ANALYSIS THAT CONTAINS ALL OF THE FOLLOWING:  
4           (A) A SUMMARY THAT EXPLAINS THE CHANGES THE BILL WOULD MAKE TO  
5 EXISTING LAW.  
6           (B) AN ESTIMATE OF THE POTENTIAL IMPACT OR AMOUNT BY WHICH THE  
7 BILL WOULD INCREASE OR DECREASE GOVERNMENTAL REVENUES AND  
8 EXPENDITURES, AND WHICH FUNDS THE BILL WOULD AFFECT. IF FEDERAL  
9 FUNDING RECEIVED BY THE STATE WOULD BE AFFECTED BY THE BILL, THE  
10 ANALYSIS MUST INCLUDE AN ESTIMATE OF THAT EFFECT.

1 (C) IF THE BILL WOULD INCREASE OR DECREASE STATE TAXES OR  
2 FEES, THE ANALYSIS MAY INCLUDE AN ESTIMATE OF THE IMPACT ON PAYERS  
3 OF THE TAXES OR FEES.

4 (D) ANY OTHER INFORMATION THE SENATE FISCAL AGENCY CONSIDERS  
5 NECESSARY TO EXPLAIN THE FISCAL EFFECT OF THE BILL INCLUDING, BUT  
6 NOT LIMITED TO, POTENTIAL IMPACTS TO LOCAL UNITS OF GOVERNMENT.

7 (2) THE SENATE FISCAL AGENCY SHALL PROVIDE THE FISCAL ANALYSIS  
8 PREPARED UNDER SUBSECTION (1) TO THE CLERK OF THE COMMITTEE AND TO  
9 THE PUBLIC ON THE INTERNET.

10 (3) THE SENATE FISCAL AGENCY SHALL PREPARE A REVISED FISCAL  
11 ANALYSIS, AS NECESSARY, THAT INCORPORATES ANY CHANGE TO A BILL  
12 DESCRIBED IN SUBSECTION (1).

13 SEC. 602. (1) THE HOUSE FISCAL AGENCY SHALL PREPARE, FOR EACH  
14 BILL THAT IS SCHEDULED FOR A HEARING BEFORE A STANDING COMMITTEE OF  
15 THE HOUSE OF REPRESENTATIVES, A FISCAL ANALYSIS THAT CONTAINS ALL  
16 OF THE FOLLOWING:

17 (A) A SUMMARY THAT EXPLAINS THE CHANGES THE BILL WOULD MAKE TO  
18 EXISTING LAW.

19 (B) AN ESTIMATE OF THE POTENTIAL IMPACT OR AMOUNT BY WHICH THE  
20 BILL WOULD INCREASE OR DECREASE GOVERNMENTAL REVENUES AND  
21 EXPENDITURES, AND WHICH FUNDS THE BILL WOULD AFFECT. IF FEDERAL  
22 FUNDING RECEIVED BY THE STATE WOULD BE AFFECTED BY THE BILL, THE  
23 ANALYSIS MUST INCLUDE AN ESTIMATE OF THAT EFFECT.

24 (C) IF THE BILL WOULD INCREASE OR DECREASE STATE TAXES OR  
25 FEES, THE ANALYSIS MAY INCLUDE AN ESTIMATE OF THE IMPACT ON PAYERS  
26 OF THE TAXES OR FEES.

27 (D) ANY OTHER INFORMATION THE HOUSE FISCAL AGENCY CONSIDERS

1 NECESSARY TO EXPLAIN THE FISCAL EFFECT OF THE BILL INCLUDING, BUT  
2 NOT LIMITED TO, POTENTIAL IMPACTS TO LOCAL UNITS OF GOVERNMENT.

3 (2) THE HOUSE FISCAL AGENCY SHALL PROVIDE THE FISCAL ANALYSIS  
4 PREPARED UNDER SUBSECTION (1) TO THE CLERK OF THE COMMITTEE AND TO  
5 THE PUBLIC ON THE INTERNET.

6 (3) THE HOUSE FISCAL AGENCY SHALL PREPARE A REVISED FISCAL  
7 ANALYSIS, AS NECESSARY, THAT INCORPORATES ANY CHANGE TO A BILL  
8 DESCRIBED IN SUBSECTION (1).

9 Enacting section 1. This amendatory act takes effect 90 days  
10 after the date it is enacted into law.
