

**HOUSE SUBSTITUTE FOR
SENATE BILL NO. 248**

A bill to create a commission to commemorate the centennial of World War I; to prescribe the powers and duties of the commission; to prescribe the powers and duties of certain state agencies and officials; and to repeal acts and parts of acts.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 1. This act shall be known and may be cited as the "World
2 War I centennial commission act".

3 Sec. 2. As used in this act:

4 (a) "Commission" means the World War I centennial commission
5 created in section 3.

6 (b) "Department" means the department of military and veterans
7 affairs.

1 (c) "Veteran" means that term as defined in section 1 of 1965
2 PA 190, MCL 35.61.

3 Sec. 3. (1) The World War I centennial commission is created
4 within the department.

5 (2) The commission shall consist of the director of the
6 department, or his or her designee, and 13 members. The governor
7 shall appoint 11 of those 13 members with the advice and consent of
8 the senate, and the senate majority leader and the speaker of the
9 house of representatives shall each appoint 1 member.

10 (3) The members first appointed to the commission must be
11 appointed within 90 days after the effective date of this act.

12 (4) If a vacancy occurs on the commission, the governor shall
13 make an appointment in the same manner as the original appointment.

14 (5) The governor may remove a member of the commission for
15 incompetence, dereliction of duty, malfeasance, misfeasance, or
16 nonfeasance in office, or any other good cause.

17 (6) The first meeting of the commission must be called by the
18 director of the department. At the first meeting, the commission
19 shall elect from among its members a chairperson and other officers
20 as it considers necessary or appropriate. After the first meeting,
21 the commission shall meet at least quarterly, or more frequently at
22 the call of the chairperson or if requested by 7 or more members.

23 (7) A majority of the members of the commission constitute a
24 quorum for the transaction of business at a meeting of the
25 commission. A majority of the members present and serving are
26 required for official action of the commission.

27 (8) The business that the commission may perform must be

1 conducted at a public meeting of the commission held in compliance
2 with the open meetings act, 1976 PA 267, MCL 15.261 to 15.275.

3 (9) A writing prepared, owned, used, in the possession of, or
4 retained by the commission in the performance of an official
5 function is subject to the freedom of information act, 1976 PA 442,
6 MCL 15.231 to 15.246.

7 (10) Members of the commission shall serve without
8 compensation. However, members of the commission may be reimbursed
9 for their actual and necessary expenses incurred in the performance
10 of their official duties as members of the commission.

11 Sec. 4. The commission shall do all of the following:

12 (a) Plan, develop, and execute programs, projects, and
13 activities to commemorate the centennial of World War I.

14 (b) Encourage private organizations and state and local
15 governments to organize and participate in activities organized by
16 the commission.

17 (c) Facilitate and coordinate World War I centennial
18 activities throughout this state.

19 (d) Serve as a clearinghouse for the collection and
20 dissemination of information about World War I centennial events
21 and plans.

22 (e) Develop recommendations on ways to commemorate the World
23 War I centennial in this state and provide a report on these
24 recommendations to the director, the governor, and the legislature.

25 Sec. 5. The department shall assist the commission in carrying
26 out its duties under this act.

27 Enacting section 1. This act is repealed December 31, 2018.
