PART 2

PROVISIONS CONCERNING APPROPRIATIONS

GENERAL SECTIONS

17 Sec. 201. Pursuant to section 30 of article IX of the state  
18 constitution of 1963, total state spending from state resources  
19 under part 1 for the fiscal year ending September 30, 2018 is  
20 \$52,850,300.00 and total state spending from state sources to be  
21 paid to local units of government is \$2,500,000.00.

22 Sec. 202. The appropriations made and expenditures authorized  
23 under this act and the departments, commissions, boards, offices,  
24 and programs for which appropriations are made under this act are  
25 subject to the management and budget act, 1984 PA 431, MCL 18.1101

1 to 18.1594.

2           Sec. 203. As used in this act, "PFAS" means perfluoroalkyl and  
3 polyfluoroalkyl substances.

4 **CAPITAL OUTLAY**

5           Sec. 301. For the state building authority financed  
6 construction authorizations in part 1, the legislature hereby  
7 determines that the leases of the facilities from the authority are  
8 for a public purpose as authorized by 1964 PA 183, MCL 830.411 to  
9 830.425. The legislature approves and authorizes the leases and  
10 conveyances of the property to the state building authority, the  
11 state building authority acquiring the facilities and leasing them  
12 to the state and the educational institutions, as applicable, and  
13 the governor and secretary of state executing the leases for and on  
14 behalf of the state pursuant to the requirements of 1964 PA 183,  
15 MCL 830.411 to 830.425. Per the requirements of the leases, it is  
16 the intent of the legislature to annually appropriate sufficient  
17 amounts to pay the rent as obligated pursuant to the leases.

18           Sec. 302. (1) For the Department of Military and Veterans  
19 Affairs - Grand Rapids and Detroit veterans home construction  
20 authorization originally approved in 2016 PA 340, the location of  
21 the Detroit veterans home is expanded to include the counties of  
22 Wayne, Oakland, and Macomb. If a site in those three counties is  
23 not selected within 45 days after the effective date of this act,  
24 the site for the location of the home shall be expanded to include  
25 the greater southeast area of Michigan.

26           (2) If a site is not selected in Wayne, Oakland, or Macomb

1 County, the department of military and veterans affairs shall  
2 provide a report to the house and senate appropriations committees  
3 and the state budget office that includes a listing of the sites  
4 considered and the reasons that those sites were considered to not  
5 be feasible for the location of the veterans home.

6 (3) The next veterans home, subsequent to the 2 originally  
7 authorized in 2016 PA 340, shall be located in Wayne, Oakland, or  
8 Macomb County.

9 **DEPARTMENT OF CORRECTIONS**

10 Sec. 401. From the funds appropriated in part 1 for the  
11 education program, the department may expend funds for college  
12 tuition and fees that exceed the Pell Grant amount for prisoners  
13 located at the Women's Huron Valley Correctional Facility that are  
14 participating in the Second Chance Pell Grant Program. Funds  
15 expended under this section may not result in a prisoner paying  
16 less than the current in-district tuition being charged to  
17 prisoners participating in classes offered by the same school.

18 **DEPARTMENT OF EDUCATION**

19 Sec. 501. (1) From the funds appropriated in part 1 for the  
20 school water training program, the department shall work with the  
21 department of environmental quality and the department of licensing  
22 and regulatory affairs to develop and implement a statewide  
23 training program to promote best practices in appropriately  
24 managing school drinking water systems. The best practices shall  
25 consist of guidance and training modules to support instruction and

1 shall be designed to educate school personnel, parents, and  
2 students.

3 (2) The school water training program shall include all of the  
4 following:

5 (a) Instruction and training on water testing.

6 (b) Instruction and training on the development of  
7 facilitywide flushing programs designed to move water through  
8 systems after periods of stagnation.

9 (c) Any other information the department of education, the  
10 department of environmental quality, or the department of licensing  
11 and regulatory affairs considers necessary to ensure school  
12 personnel are adequately trained to manage school drinking water  
13 systems.

#### 14 DEPARTMENT OF ENVIRONMENTAL QUALITY

15 Sec. 601. It is the intent of the legislature that the United  
16 States Department of Defense shall reimburse the state for costs  
17 associated with PFAS and environmental contamination response at  
18 military training sites and support facilities.

19 Sec. 602. General fund and state restricted fund  
20 appropriations in part 1 shall not be expended for PFAS and  
21 environmental contamination response where federal funding or  
22 private grant funding is available for the same expenditures.

#### 23 DEPARTMENT OF HEALTH AND HUMAN SERVICES

24 Sec. 701. From the funds appropriated for grants to local  
25 public health departments to support PFAS response activities,

1 \$2,500,000.00 shall be allocated to local public health  
2 departments. The funding shall be allocated by the department of  
3 health and human services in a collaborative fashion with local  
4 public health departments in jurisdictions experiencing potential  
5 PFAS contamination. The funding shall be allocated to address  
6 issues including, but not limited to, staffing, planning and  
7 response, and creation and dissemination of materials related to  
8 potential PFAS contamination issues.

9       Sec. 702. From funds appropriated in part 1 for  
10 transportation, the department of health and human services shall  
11 increase the number of counties in which a local public  
12 transportation entity is the primary administrator of the Medicaid  
13 nonemergency transportation benefit. The department of health and  
14 human services shall use a nonprofit transportation brokerage  
15 already operating in the state of Michigan to carry out the  
16 requirements of this section. The purpose of this expansion is to  
17 improve Medicaid beneficiary access to care, reduce the number of  
18 missed physician appointments by Medicaid beneficiaries, and reduce  
19 time spent by caseworkers facilitating nonemergency transportation  
20 for Medicaid beneficiaries. Performance goals include an increase  
21 in utilization of local public transportation, a reduction in the  
22 rate of trips reported as missed to no more than 0.5%, and the  
23 successful collection of data on program utilization, access, and  
24 beneficiary satisfaction.

25       Sec. 703. It is the intent of the legislature that the United  
26 States Department of Defense shall reimburse the state for costs  
27 associated with PFAS and environmental contamination response at

1 military training sites and support facilities.

2       Sec. 704. General fund and state restricted fund  
3 appropriations in part 1 shall not be expended for PFAS and  
4 environmental contamination response where federal funding or  
5 private grant funding is available for the same expenditures.

6 **DEPARTMENT OF TECHNOLOGY, MANAGEMENT, AND BUDGET**

7       Sec. 751. From the funds appropriated in part 1 for  
8 information technology services for the department of  
9 transportation, contingent on enactment of House Bill No. 4644 of  
10 the 99th Legislature, funding shall be used to implement a new  
11 permit type in the MDOT MiTrip application to allow businesses to  
12 apply for annual permits for power units to pull various loads and  
13 trailers that are within allowed size and weight limits.

14 **DEPARTMENT OF TREASURY**

15       Sec. 801. (1) Funds appropriated in part 1 for the Michigan  
16 infrastructure council shall be expended to fund the activities,  
17 costs, and expenses of a Michigan infrastructure council in the  
18 department of treasury. The council may utilize the funds for all  
19 of the following:

20       (a) Establishing and organizing the council.

21       (b) Undertaking research and advising on matters relating to  
22 asset management.

23       (c) Evaluating existing asset management programs.

24       (d) Developing a multiyear program, work plan, and budgeting  
25 and funding recommendation for asset management.



1 (e) Developing and publishing an annual report on the current  
2 statewide asset management assessment.

3 (2) Annually, the Michigan infrastructure council shall  
4 provide a report to the governor, the senate and house  
5 appropriations committees, the senate and house fiscal agencies,  
6 and the state budget director detailing the following:

7 (a) Council activities and accomplishments for the previous  
8 fiscal year.

9 (b) Council expenditures by categories of administration,  
10 research and education, asset management planning, and other  
11 projects.

12 **REPEALER**

13 Enacting section 1. Section 1861 of article X of 2017 PA 107  
14 is repealed.
