GENERAL SECTIONS

6 Sec. 201. Pursuant to section 30 of article IX of the state  
7 constitution of 1963, total state spending from state resources  
8 under part 1 for fiscal year 2017-2018 is \$49,866,900.00 and state  
9 spending from state resources to be paid to local units of  
10 government for fiscal year 2017-2018 is \$29,235,000.00. The  
11 itemized statement below identifies appropriations from which  
12 spending to local units of government will occur:

MICHIGAN NATURAL RESOURCES TRUST FUND

20 Sec. 301. (1) The department of natural resources shall enter  
21 into agreements with local units of government to administer the  
22 grants identified in part 1. Among other provisions, the agreements  
23 must require that grant recipients agree to dedicate to public  
24 outdoor recreation uses in perpetuity the land acquired or

1 developed; to replace lands converted or lost to other than public  
 2 outdoor recreation use; and, for parcels acquired that are larger  
 3 than 5 acres, to provide this state with a nonparticipating 1/6  
 4 minimum royalty interest in any acquired minerals that are retained  
 5 by the grant recipient.

6 (2) The agreements under subsection (1) must also provide that  
 7 the full payments of grants be made only after proof of  
 8 acquisition, or proof of completion of the development project, is  
 9 submitted by the grant recipient and all costs are verified by the  
 10 department of natural resources. This requirement may be waived by  
 11 the department of natural resources.

12 Sec. 302. The appropriations in part 1 for capital outlay  
 13 shall be carried forward at the end of the fiscal year consistent  
 14 with section 248 of the management and budget act, 1984 PA 431, MCL  
 15 18.1248.
