

# HOUSE BILL No. 4262

February 21, 2017, Introduced by Rep. Kosowski and referred to the Committee on Transportation and Infrastructure.

A bill to provide for the issuance of a military transportation card to certain veterans and active duty members of the armed forces of the United States; to prohibit a public transportation provider from charging a fare, fee, or other charge for use of public transportation to a veteran or active duty member of the armed forces of the United States upon presentation of a military transportation card; to provide for the powers and duties of certain state officers and entities; and to authorize the promulgation of rules.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 1. As used in this act:

(a) "Department" means the department of military and veterans affairs.

(b) "Public transportation provider" means a public or private

1 entity that provides public transportation services. Public  
2 transportation provider includes an authority formed under any of  
3 the following:

4 (i) 1963 PA 55, MCL 124.351 to 124.359.

5 (ii) The urban cooperation act of 1967, 1967 (Ex Sess) PA 7,  
6 MCL 124.501 to 124.512.

7 (iii) 1967 (Ex Sess) PA 8, MCL 124.531 to 124.536.

8 (iv) 1951 PA 35, MCL 124.1 to 124.13.

9 (v) The public transportation authority act, 1986 PA 196, MCL  
10 124.451 to 124.479.

11 (vi) The revenue bond act of 1933, 1933 PA 94, MCL 141.101 to  
12 141.140.

13 (c) "Veteran" means 1 of the following:

14 (i) An individual who served in the armed forces of the United  
15 States on active military duty and received an honorable discharge  
16 from active duty, if he or she served on active duty for reasons  
17 other than training or if, while serving on active duty for  
18 training, he or she incurred a disability recognized by the United  
19 States Department of Veterans Affairs or the United States  
20 Department of Defense as service-connected.

21 (ii) An individual who served in the United States Merchant  
22 Marine who served on active duty for reasons other than training or  
23 if, while serving on active duty for training, incurred a  
24 disability recognized by the United States Department of Veterans  
25 Affairs or the United States Department of Defense as service-  
26 connected, if he or she satisfies 1 of the following conditions:

27 (A) He or she received an honorable report of separation from

1 active duty military service, as shown on form DD214 or form DD215.

2 (B) He or she served in the United States Merchant Marine  
3 between December 7, 1941 and December 31, 1946.

4 Sec. 3. (1) The department shall issue a military  
5 transportation card to an applicant who satisfies all of the  
6 following:

7 (a) The applicant submits a written application stating that  
8 he or she is a veteran or an active duty member of the armed forces  
9 of the United States.

10 (b) The applicant submits documentary evidence in a form  
11 satisfactory to the department showing that he or she is a veteran  
12 or an active duty member of the armed forces of the United States.

13 (2) The department shall issue the military transportation  
14 card described in subsection (1) at no cost to the individual to  
15 whom it is issued.

16 (3) A military transportation card issued to a veteran under  
17 subsection (1) does not expire. A military transportation card  
18 issued to an active duty member of the armed forces of the United  
19 States expires on the date that his or her membership is scheduled  
20 to cease, as shown in the documentary evidence described in  
21 subsection (1)(b).

22 (4) The department may promulgate rules under the  
23 administrative procedures act of 1969, 1969 PA 306, MCL 24.201 to  
24 24.328, to implement this act.

25 Sec. 5. A public transportation provider shall not charge a  
26 fee, fare, or other charge of any kind to a veteran or active duty  
27 member of the armed forces of the United States to board or travel

1 on a bus operated by that public transportation provider if the  
2 veteran or active duty member presents a military transportation  
3 card issued under section 3.

4 Enacting section 1. This act takes effect 90 days after the  
5 date it is enacted into law.
