PROVISIONS CONCERNING APPROPRIATIONS

GENERAL SECTIONS

8 Sec. 201. Pursuant to section 30 of article IX of the state
9 constitution of 1963, total state spending from state resources
10 under part 1 for fiscal year 2016-2017 is \$2,000,000.00 and total
11 state spending from state resources to be paid to local units of
12 government for fiscal year 2016-2017 is \$0.00.

13 Sec. 202. The appropriations made and expenditures authorized
14 under this act and the departments, commissions, boards, offices,
15 and programs for which appropriations are made under this act are
16 subject to the management and budget act, 1984 PA 431, MCL 18.1101
17 to 18.1594.

STATE TRANSPORTATION DEPARTMENT

19 Sec. 301. The funds appropriated in part 1 for M-53 at 23 Mile
20 Road shall be used by the state transportation department to
21 improve traffic flow, reduce congestion, and improve safety at the
22 interchange of M-53 and 23 Mile Road in Macomb County.
