

# HOUSE BILL No. 6062

May 23, 2018, Introduced by Rep. VanSingel and referred to the Committee on Regulatory Reform.

A bill to amend 1979 PA 152, entitled  
"State license fee act,"  
by amending section 17 (MCL 338.2217), as amended by 2015 PA 75.

**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

1       Sec. 17. Fees for a person licensed or seeking licensure as a  
2 barber, student barber, student instructor, or barber instructor,  
3 for a person licensed or seeking licensure to operate a barbershop  
4 or barber college, or for a person seeking a permit for a  
5 demonstration or a demonstrator's permit under article 11 of the
