THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 134a. (1) Except as otherwise provided in subsection (2), 1 2 a psychiatric facility or other facility defined in 42 USC 1396d(d) 3 shall not employ, independently contract with, or grant clinical 4 privileges to an individual who regularly has direct access to or 5 provides direct services to patients or residents in the psychiatric facility or other facility defined in 42 USC 1396d(d) 6 7 if the individual satisfies 1 or more of the following: 8 (a) Has been convicted of a relevant crime described under 42
 - (b) Has been convicted of any of the following felonies, an attempt or conspiracy to commit any of those felonies, or any other

- 1 state or federal crime that is similar to the felonies described in
- 2 this subdivision, other than a felony for a relevant crime
- 3 described under 42 USC 1320a-7(a), unless 15 years have lapsed
- 4 since the individual completed all of the terms and conditions of

- 6 prior to BEFORE the date of application for employment or clinical
- 7 privileges or the date of the execution of the independent
- 8 contract:

- 20 applicant to the relevant licensing or regulatory department OF
- 21 LICENSING AND REGULATORY AFFAIRS to conduct a check of all relevant
- 22 registries in the manner required in subsection (4). If the
- 23 requirements of subsection $\frac{(10)}{(6)}$ are not met and a request to
- 24 the federal bureau of investigation FEDERAL BUREAU OF INVESTIGATION
- 25 to make a subsequent determination of the existence of any national
- 26 criminal history pertaining to the applicant is necessary, the
- 27 psychiatric facility or other facility defined in 42 USC 1396d(d)

- 1 or staffing agency shall proceed in the manner required in
- 2 subsection (4). A staffing agency that employs an applicant who
- 3 regularly has direct access to or provides direct services to
- 4 patients or residents under an independent contract with a
- 5 psychiatric facility or other facility defined in 42 USC 1396d(d)
- 6 shall submit information regarding the criminal history check
- 7 conducted by the staffing agency to the psychiatric facility or
- 8 other facility defined in 42 USC 1396d(d) that has made a good-
- 9 faith offer of independent contract to that applicant.
- 10 (4) Upon receipt of the written consent to conduct a criminal
- 11 history check and identification required under subsection (3), a
- 12 psychiatric facility or other facility defined in 42 USC 1396d(d)
- 13 or staffing agency that has made a good-faith offer of employment
- 14 or an independent contract or clinical privileges to the applicant
- 15 shall make a request to the department of state police to conduct a
- 16 criminal history check on the applicant, to input the applicant's
- 17 fingerprints into the automated fingerprint identification system
- 18 database, and to forward the applicant's fingerprints to the
- 19 federal bureau of investigation. FEDERAL BUREAU OF INVESTIGATION.
- 20 The department of state police shall request the federal bureau of
- 21 investigation FEDERAL BUREAU OF INVESTIGATION to make a
- 22 determination of the existence of any national criminal history
- 23 pertaining to the applicant. The applicant shall provide the
- 24 department of state police with a set of fingerprints. The request
- 25 shall be made in a manner prescribed by the department of state
- 26 police. The psychiatric facility or other facility defined in 42
- 27 USC 1396d(d) or staffing agency shall make the written consent and

- 1 identification available to the department of state police. The
- 2 psychiatric facility or other facility defined in 42 USC 1396d(d)
- 3 or staffing agency shall make a request regarding that applicant to
- 4 the relevant licensing or regulatory department OF LICENSING AND

- 11 other facility defined in 42 USC 1396d(d) or staffing agency shall
- 12 pay the cost of the charge. The psychiatric facility or other
- 13 facility defined in 42 USC 1396d(d) or staffing agency shall not
- 14 seek reimbursement for a charge imposed by the department of state
- 15 police or the federal bureau of investigation FEDERAL BUREAU OF
- 16 INVESTIGATION from the individual who is the subject of the
- 17 criminal history check. A prospective employee or a prospective
- 18 independent contractor covered under this section may not be
- 19 charged for the cost of a criminal history check required under
- 20 this section. The department of state police shall conduct a
- 21 criminal history check on the applicant named in the request. The
- 22 department of state police shall provide the department OF
- 23 LICENSING AND REGULATORY AFFAIRS with a written report of the
- 24 criminal history check conducted under this subsection. The report
- 25 shall contain any criminal history record information on the
- 26 applicant maintained by the department of state police. The

(5) If a psychiatric facility or other facility defined in 42 1 2 USC 1396d(d) determines it necessary to employ or grant clinical 3 privileges to an applicant before receiving the results of the 4 applicant's criminal history check or criminal history record information under this section, the psychiatric facility or other 5 facility defined in 42 USC 1396d(d) may conditionally employ or 6 grant conditional clinical privileges to the individual if all of 7 the following apply: 8 (a) The psychiatric facility or other facility defined in 42 9 10 USC 1396d(d) requests the criminal history check or criminal 11 history record information under this section upon conditionally 12 employing or conditionally granting clinical privileges to the individual. 13 14 (b) The individual signs a statement in writing that indicates 15 all of the following: (i) That he or she has not been convicted of 1 or more of the 16 17 crimes that are described in subsection (1)(a) through (g) within 18 the applicable time period prescribed by each subdivision 19 respectively. (v) That he or she understands the conditions described in 5 subparagraphs (i) through (iv) that result in the termination of 6 his or her employment or clinical privileges and that those 7 conditions are good cause for termination. 8 9 (c) Except as otherwise provided in this subdivision, the 10 psychiatric facility or other facility defined in 42 USC 1396d(d) 11 does not permit the individual to have regular direct access to or 12 provide direct services to patients or residents in the psychiatric facility or other facility defined in 42 USC 1396d(d) without 13 14 supervision until the criminal history check or criminal history record information is obtained and the individual is eligible for 15 16 that employment or clinical privileges. A psychiatric facility or other facility defined in 42 21 USC 1396d(d) or staffing agency or an employee of the psychiatric facility or other facility defined in 42 USC 1396d(d) or staffing 22 23 agency shall not disclose criminal history record information obtained under subsection (3) or (4) to a person who is not 24 25 directly involved in evaluating the applicant's qualifications for 26 employment, an independent contract, or clinical privileges. An 27 individual who knowingly uses or disseminates the criminal history

- 1 record information obtained under subsection (3) or (4) in
- 2 violation of this subsection is guilty of a misdemeanor punishable
- 3 by imprisonment for not more than 93 days or a fine of not more
- 4 than \$1,000.00, or both. Except for a knowing or intentional

- 15 licensing or regulatory department OF LICENSING AND REGULATORY

- 25 (a) Agree in writing to report to the psychiatric facility or
- 26 other facility defined in 42 USC 1396d(d) or staffing agency
- 27 immediately upon being arraigned for 1 or more of the criminal

- 2 convicted of 1 or more of the criminal offenses listed in

- 8 circuit court for a violation that if committed by an adult would

- 21 employed by or under independent contract with a psychiatric
- 22 facility or other facility defined in 42 USC 1396d(d) for whom the
- 23 psychiatric facility or other facility defined in 42 USC 1396d(d)
- 24 does both of the following:
- 25 (i) Determines whether the individual who has access to
- 26 patients or residents may provide care, treatment, or other similar
- 27 support service functions to patients or residents served by the

- 1 psychiatric facility or other facility defined in 42 USC 1396d(d).
- 2 (ii) Directs or oversees 1 or more of the following:
- 3 (A) The policy or procedures the individual must follow in
