

SENATE BILL No. 181

February 23, 2017, Introduced by Senators HILDENBRAND, SCHUITMAKER and HOPGOOD and referred to the Committee on Families, Seniors and Human Services.

A bill to amend 1973 PA 116, entitled

"An act to provide for the protection of children through the licensing and regulation of child care organizations; to provide for the establishment of standards of care for child care organizations; to prescribe powers and duties of certain departments of this state and adoption facilitators; to provide penalties; and to repeal acts and parts of acts,"

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

2 (A) "CHILD CARE STAFF MEMBER" MEANS AN INDIVIDUAL WHO IS 18
3 YEARS OF AGE OR OLDER TO WHOM 1 OR MORE OF THE FOLLOWING APPLIES:

4 (i) THE INDIVIDUAL IS EMPLOYED BY A CHILD CARE CENTER, GROUP
5 CHILD CARE HOME, OR FAMILY CHILD CARE HOME FOR COMPENSATION,
6 INCLUDING A CONTRACT EMPLOYEE OR A SELF-EMPLOYED INDIVIDUAL.

7 (ii) AN INDIVIDUAL WHOSE ACTIVITIES INVOLVE THE UNSUPERVISED
8 CARE OR SUPERVISION OF CHILDREN FOR A CHILD CARE CENTER, GROUP
9 CHILD CARE HOME, OR FAMILY CHILD CARE HOME.

10 (iii) AN INDIVIDUAL WHO HAS UNSUPERVISED ACCESS TO CHILDREN
11 WHO ARE CARED FOR OR SUPERVISED BY A CHILD CARE CENTER, GROUP CHILD
12 CARE HOME, OR FAMILY CHILD CARE HOME.

13 (B) ~~(a)~~—"Child care organization" means a governmental or
14 nongovernmental organization having as its principal function
15 receiving minor children for care, maintenance, training, and

1 supervision, notwithstanding that educational instruction may be
2 given. Child care organization includes organizations commonly
3 described as child caring institutions, child placing agencies,
4 children's camps, children's campsites, children's therapeutic
5 group homes, child care centers, day care centers, nursery schools,
6 parent cooperative preschools, foster homes, group homes, or child
7 care homes. Child care organization does not include a governmental
8 or nongovernmental organization that does either of the following:

9 (i) Provides care exclusively to minors who have been
10 emancipated by court order under section 4(3) of 1968 PA 293, MCL
11 722.4.

12 (ii) Provides care exclusively to persons who are 18 years of
13 age or older and to minors who have been emancipated by court order
14 under section 4(3) of 1968 PA 293, MCL 722.4, at the same location.

15 (C) ~~(b)~~—"Child caring institution" means a child care facility
16 that is organized for the purpose of receiving minor children for
17 care, maintenance, and supervision, usually on a 24-hour basis, in
18 buildings maintained by the child caring institution for that
19 purpose, and operates throughout the year. An educational program
20 may be provided, but the educational program shall not be the
21 primary purpose of the facility. Child caring institution includes
22 a maternity home for the care of unmarried mothers who are minors
23 and an agency group home, that is described as a small child caring
24 institution, owned, leased, or rented by a licensed agency
25 providing care for more than 4 but less than 13 minor children.
26 Child caring institution also includes institutions for
27 developmentally disabled or emotionally disturbed minor children.

1 Child caring institution does not include a hospital, nursing home,
2 or home for the aged licensed under article 17 of the public health
3 code, 1978 PA 368, MCL 333.20101 to 333.22260, a boarding school
4 licensed under section 1335 of the revised school code, 1976 PA
5 451, MCL 380.1335, a hospital or facility operated by the state or
6 licensed under the mental health code, 1974 PA 258, MCL 330.1001 to
7 330.2106, or an adult foster care family home or an adult foster
8 care small group home licensed under the adult foster care facility
9 licensing act, 1979 PA 218, MCL 400.701 to 400.737, in which a
10 child has been placed under section 5(6).

11 (D) ~~(e)~~—"Child placing agency" means a governmental
12 organization or an agency organized under the nonprofit corporation
13 act, 1982 PA 162, MCL 450.2101 to 450.3192, for the purpose of
14 receiving children for placement in private family homes for foster
15 care or for adoption. The function of a child placing agency may
16 include investigating applicants for adoption and investigating and
17 certifying foster family homes and foster family group homes as
18 provided in this act. The function of a child placing agency may
19 also include supervising children who are at least 16 but less than
20 21 years of age and who are living in unlicensed residences as
21 provided in section 5(4).

22 (E) ~~(d)~~—"Children's camp" means a residential, day, troop, or
23 travel camp that provides care and supervision and is conducted in
24 a natural environment for more than 4 children, apart from the
25 children's parents, relatives, or legal guardians, for 5 or more
26 days in a 14-day period.

27 (F) ~~(e)~~—"Children's campsite" means the outdoor setting where

1 a children's residential or day camp is located.

2 (G) ~~(F)~~—"Children's therapeutic group home" means a child
3 caring institution receiving not more than 6 minor children who are
4 diagnosed with a developmental disability as defined in section
5 100a of the mental health code, 1974 PA 258, MCL 330.1100a, or a
6 serious emotional disturbance as defined in section 100d of the
7 mental health code, 1974 PA 258, MCL 330.1100d, and that meets all
8 of the following requirements:

9 (i) Provides care, maintenance, and supervision, usually on a
10 24-hour basis.

11 (ii) Complies with the rules for child caring institutions,
12 except that behavior management rooms, personal restraint,
13 mechanical restraint, or seclusion, which is allowed in certain
14 circumstances under licensing rules, are prohibited in a children's
15 therapeutic group home.

16 (iii) Is not a private home.

17 (iv) Is not located on a campus with other licensed
18 facilities.

19 (H) ~~(G)~~—"Child care center" ~~or "day care center"~~ means a
20 facility, other than a private residence, receiving 1 or more
21 ~~preschool or school-age children~~ **UNDER 13 YEARS OF AGE** for care for
22 periods of less than 24 hours a day, where the parents or guardians
23 are not immediately available to the child. Child care center ~~or~~
24 ~~day care center~~ includes a facility that provides care for not less
25 than 2 consecutive weeks, regardless of the number of hours of care
26 per day. The facility is generally described as a child care
27 center, day care center, day nursery, nursery school, parent

1 cooperative preschool, play group, before- or after-school program,
2 or drop-in center. Child care center ~~or day care center~~ does not
3 include any of the following:

4 (i) A Sunday school, a vacation bible school, or a religious
5 instructional class that is conducted by a religious organization
6 where children are attending for not more than 3 hours per day for
7 an indefinite period or for not more than 8 hours per day for a
8 period not to exceed 4 weeks during a 12-month period.

9 (ii) A facility operated by a religious organization where
10 children are in the religious organization's care for not more than
11 3 hours while persons responsible for the children are attending
12 religious services.

13 (iii) A program that is primarily supervised, school-age-
14 child-focused training in a specific subject, including, but not
15 limited to, dancing, drama, music, or religion. This exclusion
16 applies only to the time a child is involved in supervised, school-
17 age-child-focused training.

18 (iv) A program that is primarily an incident of group athletic
19 or social activities for school-age children sponsored by or under
20 the supervision of an organized club or hobby group, including, but
21 not limited to, youth clubs, scouting, and school-age recreational
22 or supplementary education programs. This exclusion applies only to
23 the time the school-age child is engaged in the group athletic or
24 social activities and if the school-age child can come and go at
25 will.

26 (v) **A PROGRAM THAT PRIMARILY PROVIDES THERAPEUTIC SERVICES TO**
27 **A CHILD.**

1 (I) "CONVICTION" MEANS A FINAL CONVICTION, THE PAYMENT OF A
2 FINE, A PLEA OF GUILTY OR NOLO CONTENDERE IF ACCEPTED BY THE COURT,
3 A FINDING OF GUILT FOR A CRIMINAL LAW VIOLATION OR A JUVENILE
4 ADJUDICATION OR DISPOSITION BY THE JUVENILE DIVISION OF PROBATE
5 COURT OR FAMILY DIVISION OF CIRCUIT COURT FOR A VIOLATION THAT IF
6 COMMITTED BY AN ADULT WOULD BE A CRIME, OR A CONVICTION IN A TRIBAL
7 COURT OR A MILITARY COURT.

8 (J) "CRIMINAL HISTORY CHECK" MEANS A FINGERPRINT-BASED
9 CRIMINAL HISTORY RECORD INFORMATION BACKGROUND CHECK THROUGH THE
10 DEPARTMENT OF STATE POLICE AND THE FEDERAL BUREAU OF INVESTIGATION.

11 (K) "CRIMINAL HISTORY RECORD INFORMATION" MEANS THAT TERM AS
12 DEFINED IN SECTION 1A OF 1925 PA 289, MCL 28.241A.

13 (L) ~~(h)~~ "Department" means the department of HEALTH AND human
14 services AND THE DEPARTMENT OF LICENSING AND REGULATORY AFFAIRS or
15 a successor agency or department responsible for licensure and
16 registration under this act. THE DEPARTMENT OF LICENSING AND
17 REGULATORY AFFAIRS IS RESPONSIBLE FOR LICENSING AND REGULATORY
18 MATTERS FOR CHILD CARE CENTERS, GROUP CHILD CARE HOMES, FAMILY
19 CHILD CARE HOMES, CHILDREN'S CAMPS, AND CHILDREN'S CAMPSITES. THE
20 DEPARTMENT OF HEALTH AND HUMAN SERVICES IS RESPONSIBLE FOR
21 LICENSING AND REGULATORY MATTERS FOR CHILD CARING INSTITUTIONS,
22 CHILD PLACING AGENCIES, CHILDREN'S THERAPEUTIC GROUP HOMES, FOSTER
23 FAMILY HOMES, AND FOSTER FAMILY GROUP HOMES.

24 (M) "ELIGIBLE" MEANS THAT THE INDIVIDUAL OBTAINED THE CHECKS
25 AND CLEARANCES DESCRIBED IN SECTIONS 5N AND 5Q AND IS CONSIDERED
26 APPROPRIATE TO OBTAIN A LICENSE, TO BE A MEMBER OF THE HOUSEHOLD OF
27 A GROUP CHILD CARE HOME OR FAMILY CHILD CARE HOME, OR TO BE A CHILD

1 CARE STAFF MEMBER.

2 (N) "INELIGIBLE" MEANS THAT THE INDIVIDUAL OBTAINED THE CHECKS
3 AND CLEARANCES AS DESCRIBED IN SECTIONS 5N AND 5Q AND IS NOT
4 CONSIDERED APPROPRIATE TO OBTAIN A LICENSE, TO BE A MEMBER OF THE
5 HOUSEHOLD OF A GROUP CHILD CARE HOME OR FAMILY CHILD CARE HOME, OR
6 TO BE A CHILD CARE STAFF MEMBER DUE TO VIOLATION OF SECTION 5N, 5Q,
7 OR 5R.

8 (O) ~~(i)~~ "Private home" means a private residence in which the
9 licensee ~~or registrant~~ permanently resides, ~~as a member of the~~
10 ~~household,~~ which residency is not contingent upon caring for
11 children or employment by a ~~licensed or approved~~ child placing
12 agency. Private home includes a full-time foster family home, a
13 full-time foster family group home, a group child care home, or a
14 family child care home, as follows:

15 (i) "Foster family home" means a private home in which 1 but
16 not more than 4 minor children, who are not related to an adult
17 member of the household by blood or marriage, or who are not placed
18 in the household under the Michigan adoption code, chapter X of the
19 probate code of 1939, 1939 PA 288, MCL 710.21 to 710.70, are given
20 care and supervision for 24 hours a day, for 4 or more days a week,
21 for 2 or more consecutive weeks, unattended by a parent, legal
22 guardian, or legal custodian.

23 (ii) "Foster family group home" means a private home in which
24 more than 4 but fewer than 7 minor children, who are not related to
25 an adult member of the household by blood or marriage, or who are
26 not placed in the household under the Michigan adoption code,
27 chapter X of the probate code of 1939, 1939 PA 288, MCL 710.21 to

1 710.70, are provided care for 24 hours a day, for 4 or more days a
2 week, for 2 or more consecutive weeks, unattended by a parent,
3 legal guardian, or legal custodian.

4 (iii) "Family child care home" means a private home in which ~~±~~
5 3 but fewer than 7 minor children are received for care and
6 supervision for compensation for periods of less than 24 hours a
7 day, unattended by a parent or legal guardian, except children
8 related to an adult member of the ~~family~~**HOUSEHOLD** by blood,
9 marriage, or adoption. Family child care home includes a home in
10 which care is given to an unrelated minor child for more than 4
11 weeks during a calendar year. A family child care home does not
12 include an individual providing babysitting services for another
13 individual. As used in this subparagraph, "providing babysitting
14 services" means caring for a child on behalf of the child's parent
15 or guardian when the annual compensation for providing those
16 services does not equal or exceed \$600.00 or an amount that would
17 according to the internal revenue code of 1986 obligate the child's
18 parent or guardian to provide a form 1099-MISC to the individual
19 for compensation paid during the calendar year for those services.

20 (iv) "Group child care home" means a private home in which
21 more than 6 but not more than 12 minor children are given care and
22 supervision for periods of less than 24 hours a day unattended by a
23 parent or legal guardian, except children related to an adult
24 member of the ~~family~~**HOUSEHOLD** by blood, marriage, or adoption.
25 Group child care home includes a home in which care is given to an
26 unrelated minor child for more than 4 weeks during a calendar year.

27 (P) ~~(j)~~—"Legal custodian" means an individual who is at least

1 18 years of age in whose care a minor child remains or is placed
2 after a court makes a finding under section 13a(5) of chapter XIIA
3 of the probate code of 1939, 1939 PA 288, MCL 712A.13a.

4 (Q) ~~(k)~~ "Licensee" means a person, partnership, firm,
5 corporation, association, nongovernmental organization, or local or
6 state government ~~child care~~ organization that has been issued a
7 license under this act to operate a child care organization.

8 (R) "LISTED OFFENSE" MEANS THAT TERM AS DEFINED IN SECTION 2
9 OF THE SEX OFFENDERS REGISTRATION ACT, 1994 PA 295, MCL 28.722.

10 (S) "MEMBER OF THE HOUSEHOLD" MEANS ANY INDIVIDUAL WHO RESIDES
11 IN A FAMILY CHILD CARE HOME, GROUP CHILD CARE HOME, FOSTER FAMILY
12 HOME, OR FOSTER FAMILY GROUP HOME ON AN ONGOING BASIS, OR WHO HAS A
13 RECURRENT PRESENCE IN THE HOME, INCLUDING, BUT NOT LIMITED TO,
14 OVERNIGHT STAYS. A MEMBER OF THE HOUSEHOLD DOES NOT INCLUDE A CHILD
15 TO WHOM CHILD CARE IS BEING PROVIDED OR A FOSTER CHILD.

16 (T) "ORIGINAL LICENSE" MEANS A LICENSE ISSUED TO A CHILD CARE
17 ORGANIZATION DURING THE FIRST 6 MONTHS OF OPERATION INDICATING THAT
18 THE ORGANIZATION IS IN COMPLIANCE WITH ALL RULES PROMULGATED BY THE
19 DEPARTMENT UNDER THIS ACT.

20 (U) ~~(l)~~ "Provisional license" means a license issued to a
21 child care organization that is temporarily unable to conform to
22 ~~all of the~~ rules promulgated under this act.

23 (V) ~~(m)~~ "Regular license" means a license issued to a child
24 care organization indicating that the organization is in
25 **SUBSTANTIAL** compliance with all rules promulgated under this act
26 **AND, IF THERE IS A DEFICIENCY, HAS ENTERED INTO A CORRECTIVE ACTION**
27 **PLAN.**

1 (W) ~~(n)~~—"Guardian" means the guardian of the person.

2 (X) ~~(e)~~—"Minor child" means any of the following:

3 (i) A person less than 18 years of age.

4 (ii) A person who is a resident in a child caring institution,
5 foster family home, or foster family group home, who is at least 18
6 but less than 21 years of age, and who meets the requirements of
7 the young adult voluntary foster care act, **2011 PA 225, MCL 400.641**
8 **TO 400.671.**

9 (iii) A person who is a resident in a child caring
10 institution, children's camp, foster family home, or foster family
11 group home; who becomes 18 years of age while residing in a child
12 caring institution, children's camp, foster family home, or foster
13 family group home; and who continues residing in a child caring
14 institution, children's camp, foster family home, or foster family
15 group home to receive care, maintenance, training, and supervision.
16 A minor child under this subparagraph does not include a person 18
17 years of age or older who is placed in a child caring institution,
18 foster family home, or foster family group home under an
19 adjudication under section 2(a) of chapter XIIA of the probate code

15 issued under this act to a family child care home through
16 registration.~~

5 ~~be enrolled in~~ **ATTEND** a grade of kindergarten or ~~above,~~ **HIGHER**, but
6 is less than 13 years of age. **A CHILD IS CONSIDERED TO BE A SCHOOL-**
7 **AGE CHILD ON THE FIRST DAY OF THE SCHOOL YEAR IN WHICH HE OR SHE IS**
8 **ELIGIBLE TO ATTEND SCHOOL.**
