

HOUSE BILL NO. 4687

June 04, 2019, Introduced by Reps. Hoitenga, Alexander, Steven Johnson, Mueller and LaFave and referred to the Committee on Government Operations.

A bill to amend 1994 PA 451, entitled "Natural resources and environmental protection act," by amending sections 40102, 40111a, and 43527a (MCL 324.40102, 324.40111a, and 324.43527a), section 40102 as amended by 2015 PA 24, section 40111a as amended by 2015 PA 265, and section 43527a as added by 2013 PA 108.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 40102. (1) "Animals" means wild birds and wild mammals.
- 2 (2) "Bag limit" means the number of animals that may be taken
- 3 and possessed as determined by the department.



1 (3) "Bow" means a device for propelling an arrow from a string
2 drawn, held, and released by hand where the force used to hold the
3 string in the drawn position is provided by the archer's muscles.

4 (4) "Buy" or "sell" means an exchange or attempt or offer to
5 exchange for money, barter, or anything of value.

6 (5) "Chase" means to follow animals with dogs or other wild or
7 domestic animals trained for that purpose.

8 (6) "Cormorant damage" means adverse impacts of double-crested
9 cormorants on fish, fish hatchery stock, wildlife, plants, and
10 their habitats and on man-made structures.

11 (7) "Cormorant depredation order" means the depredation order
12 for double-crested cormorants to protect public resources, 50 CFR
13 21.48, issued by the United States Department of the Interior, Fish
14 and Wildlife Service.

15 (8) "Crossbow" means a weapon consisting of a bow mounted
16 transversely on a stock or frame and designed to fire an arrow,
17 bolt, or quarrel by the release of a bow string that is controlled
18 by a mechanical or electric trigger and has a working safety and a
19 draw weight of 100 pounds or greater.

20 (9) **"Deer or elk baiting" means the depositing, distributing,**
21 **or tending of feed in an area frequented by wild, free-ranging**
22 **white-tailed deer or elk to aid in the taking of deer or elk. Deer**
23 **or elk baiting does not include any of the following:**

24 (a) **Feeding wild birds or other wildlife if done in such a**
25 **manner as to exclude wild, free-ranging white-tailed deer and elk**
26 **from gaining access to the feed.**

27 (b) **The scattering of feed solely as the result of normal**
28 **logging practices or normal agricultural practices.**

29 (c) **The storage or use of feed for agricultural purposes if 1**

2 (i) The area is occupied by livestock actively consuming the

9 distributing, or tending of feed in an area frequented by wild,

13 manner as to exclude wild, free-ranging white-tailed deer and elk
14 from gaining access to the feed.

15 (b) The scattering of feed solely as the result of normal
16 logging practices or normal agricultural practices.

17 (c) The storage or use of feed for agricultural purposes if 1
18 or more of the following apply:

27 (11) ~~(10)~~ "Disability" means a determinable physical
28 characteristic of an individual that may result from disease,
29 injury, congenital condition of birth, or functional disorder.



1 (12) ~~(11)~~-"Feed" means a substance composed of grain, mineral,
2 salt, fruit, vegetable, hay, or any other food material or
3 combination of these materials, whether natural or manufactured,
4 that may attract white-tailed deer or elk. Feed does not include
5 any of the following:

6 (a) Plantings for wildlife.

7 (b) Standing farm crops under normal agricultural practices.

8 (c) Agricultural commodities scattered solely as the result of
9 normal agricultural practices.

10 (13) ~~(12)~~-"Firearm" means any weapon which will, is designed
11 to, or may readily be converted to expel a projectile by action of
12 an explosive. A pneumatic gun, as defined in section 1 of 1990 PA
13 319, MCL 123.1101, other than a paintball gun that expels by
14 pneumatic pressure plastic balls filled with paint for the purpose
15 of marking the point of impact, is also considered a firearm for
16 the purpose of this act.

13 **(2) Except as otherwise provided in this subsection, an**
 14 **individual may engage in deer or elk baiting in this state during**
 15 **the open seasons for deer or elk if that individual does not**
 16 **deposit more than 5 gallons of feed at each bait site. An**
 17 **individual shall not engage in deer or elk baiting in any area of**
 18 **this state where bovine tuberculosis has been detected in deer.**

19 ~~Sec. 43527a. (1) Beginning March 1, 2014, only~~ **Only** an
 20 individual holding a valid base license is eligible to purchase a
 21 deer license or an antlerless deer license, pursuant to current
 22 regulations. The fee for a deer license or an antlerless deer
 23 license is \$20.00.

24 ~~(2) Beginning March 1, 2014, the~~ **The** department shall charge a
 25 nonrefundable application fee not to exceed \$5.00 for each
 26 individual who applies for an antlerless deer license.

27 (3) The department may issue a kill tag with or as part of
 28 each deer license. The kill tag shall bear the license number. The
 29 kill tag may also include space for other pertinent information



1 required by the department. The kill tag, if issued, is part of the
2 license.

3 (4) Where authorized by the department, a resident may
4 purchase a second deer license for the fee assessed under this
5 subsection for the deer license for which that individual is
6 eligible. However, a senior license discount is not available for
7 the purchase of a second deer license. Where authorized by the
8 department, a nonresident may purchase an additional deer license
9 or antlerless deer license under this section for \$170.00. ~~The~~
10 **Except as otherwise provided in subsection (5), the** department may
11 issue orders under part 401 designating the kind of deer that may
12 be taken and the geographic area in which any license issued under
13 this section is valid, when advisable in managing deer.

14 (5) **The department shall not prohibit an individual with a**
15 **valid deer license from taking any antlered deer, regardless of the**
16 **number of antler points on that deer, in any area of this state in**
17 **which deer have tested positive for chronic wasting disease.**

18 (6) As used in this section, "antlered deer" means a deer
19 having at least 1 antler that extends 3 inches or more above the
20 skull.
