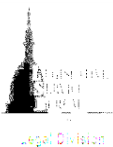

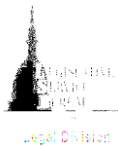

6 PROVISIONS CONCERNING APPROPRIATIONS

7 **GENERAL SECTIONS**

8 Sec. 201. In accordance with section 30 of article IX of the
 9 state constitution of 1963, total state spending from state sources
 10 in this appropriation act for the fiscal year ending September 30,
 11 2020 is \$7,995,200.00 and state spending from state sources to be
 12 aid to local units of government is \$0.00.

13 Sec. 202. The appropriations made and expenditures authorized
 14 under this act and the departments, commissions, boards, offices,
 15 and programs for which appropriations are made under this act are
 16 subject to the management and budget act, 1984 PA 431, MCL 18.1101
 17 to 18.1594.

19 **DEPARTMENT OF HEALTH AND HUMAN SERVICES**

20 Sec. 301. From the funds appropriated in part 1 for hospital
 21 services and therapy, \$7,995,200.00 in general fund/general purpose
 22 revenue shall be provided as lump-sum payments to noncritical
 23 access hospitals that qualified for rural hospital access payments
 24 in fiscal year 2013-2014 and that provide obstetrical care in the
 25 current fiscal year. Payment amounts shall be based on the volume
 26 of obstetrical care cases and newborn care cases for all such cases
 27 billed by each qualified hospital in the most recent year for which
 28 data are available. Payments shall be made by January 1 of the
 29 current fiscal year.
