- 3 Whereas, A group of World War I service members gathered in
- 4 Paris, France on March 15, 1919 to organize a new veteran service

- 1 organization; and
- 2 Whereas, The American Legion has been a staunch advocate for
- 3 veterans and their families since 1919; and
- 4 Whereas, The American Legion began its journey when Colonel
- 5 Fred M. Alger was appointed Chairman of the Michigan Temporary
- 6 Committee of the New York meeting which met under the leadership of
- 7 Theodore Roosevelt Jr.; and
- 8 Whereas, The American Legion of the Department of Michigan
- 9 held its first meeting in the Hotel Statler in St. Louis, Missouri;
- **10** and
- 11 Whereas, The American Legion of the Department of Michigan was
- 12 then divided according to Congressional Districts with George C.
- 13 Waldo as Temporary Chairman, Benjamin B. Bellows as Temporary Vice
- 14 Commander, and Lyle B. Tabor Temporary Adjutant; and
- 15 Whereas, The American Legion Department of Michigan was
- 16 incorporated under a State Charter and headquartered in Detroit.
- 17 The headquarters relocated to Lansing in 1974, while maintaining a
- 18 Veterans Affairs & Rehabilitation office in Detroit; and
- 19 Whereas, The American Legion Department of Michigan has
- 20 fulfilled the Legion's mission since 1919 through programs such as
- 21 Boys State, Scouting, an American Legion Hospital, American Legion
- 22 Children's Home, the American Legion Riders, Baseball, Accredited
- 23 Veteran Service Officers, and many others throughout the decades;

- 25 Whereas, The American Legion was founded on the four pillars
- 26 of care for veterans, a strong national defense, Americanism, as
- 27 well as our children and youth; and
- 28 Whereas, The American Legion has played a leading role in
- 29 initiatives and breakthroughs that have affected the lives of

- 1 Americans in every community, from the United States Flag Code to
- 2 the GI Bill; and
- 3 Whereas, The American Legion is celebrating its centennial
- 4 anniversary on March 15, 2019 and we want to thank The American
- 5 Legion Department of Michigan and the veterans it serves for one
- 6 hundred years of dedicated service and commitment to all Michigan
- 7 Veterans; now, therefore, be it
- 8 Resolved by the Senate, That the members of this legislative
- 9 body commemorate the 100th Anniversary of the American Legion and
- 10 honor all 56,567 members who live in the state of Michigan and the
- 11 2 million members who live in the United States; and be it further
- 12 Resolved, That copies of this resolution be transmitted to the
- 13 American Legion's Commander of the Department of Michigan.
