Cambensy, Howell, Sowerby, VanSingel, Tate, Rabhi, Borton, Kuppa, Martin, O'Malley, Manoogian, Pohutsky, Anthony, Brixie, Liberati, Hood, Markkanen, Breen, Morse, Cavanagh, Aiyash, Puri, Brabec, Brenda Carter and Hammoud and referred to the Committee on Natural Resources and Outdoor Recreation.

A bill to amend 1994 PA 451, entitled "Natural resources and environmental protection act," by amending sections 11504, 11505, 11506, 11507, 11507a, and 11508 (MCL 324.11504, 324.11505, 324.11506, 324.11507, 324.11507a, and 324.11508), section 11504 as amended by 2020 PA 85, section 11505 as amended by 2018 PA 640, section 11506 as amended by 2018 PA 615, and section 11507a as amended by 2004 PA 39.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 11504. (1) ~~"Health officer" means a full-time~~

1 ~~administrative officer of a certified health department.~~ "Hauler"
2 means a person who owns or operates a managed materials
3 transporting unit.

4 (2) "Host community approval" means an agreement, resolution,
5 letter, or other document indicating that the governing body of the
6 municipality where the materials management facility is proposed to
7 be located has reviewed and approved the development of that
8 specific facility.

9 (3) "Household waste" means solid waste that is generated from
10 single-family dwellings. Household waste does not include
11 commercial waste, industrial waste, hazardous waste, or
12 construction and demolition waste.

13 (4) ~~(2)~~—"Industrial waste" means solid waste that is generated
14 by manufacturing or industrial processes **at an industrial site** and
15 that is not a hazardous waste regulated under part 111.

16 (5) ~~(3)~~—"Industrial waste landfill" means a landfill that is
17 used for the disposal of any of the following, as applicable:

18 (a) Industrial waste that has been characterized for hazard
19 and that has been determined to be nonhazardous under part 111.

20 (b) If the landfill is an existing disposal area, nonhazardous
21 solid waste that originates from an industrial site.

22 (6) ~~(4)~~—"Inert material" means any of the following:

23 (a) Rock.

24 (b) Trees, stumps, and other similar land-clearing debris, if
25 all of the following conditions are met:

26 (i) The debris is buried on the site of origin or another site,
27 with the approval of the owner of the site.

28 (ii) The debris is not buried in a wetland or floodplain.

29 (iii) The debris is placed at least 3 feet above the groundwater

1 table as observed at the time of placement.

2 (iv) The placement of the debris does not violate federal,
3 state, or local law or create a nuisance.

4 (c) Uncontaminated excavated soil or dredged sediment.

5 Excavated soil or dredged sediment is considered uncontaminated if
6 it does not contain more than de minimis amounts of solid waste and
7 ~~1-any~~ of the following ~~applies~~**apply**:

8 (i) The soil or sediment is not contaminated by a hazardous
9 substance as a result of human activity. Soil or sediment that
10 naturally contains elevated levels of hazardous substances above
11 unrestricted residential or any other part 201 generic soil cleanup
12 criteria is not considered contaminated for purposes of this
13 subdivision. A soil or sediment analysis is not required under this
14 subparagraph if, based on past land use, there is no reason to
15 believe that the soil or sediment is contaminated.

16 (ii) For any hazardous substance that could reasonably be
17 expected to be present as a result of past land use and human
18 activity, the soil or sediment does not exceed the background
19 concentration, as that term is defined in ~~part 201~~**section 20101**.

20 (iii) For any hazardous substance that could reasonably be
21 expected to be present as a result of past land use and human
22 activity, the soil or sediment falls below part 201 generic
23 residential soil direct contact cleanup criteria and hazardous
24 substances in leachate from the soil or sediment, using, at the
25 option of the generator, EPA method 1311, "**Toxicity Characteristic**
26 **Leaching Procedure**", EPA method 1312, "**Synthetic Precipitation**
27 **Leaching Procedure**", or any other leaching protocol approved by the
28 department, fall below part 201 generic residential health based
29 groundwater drinking water values or criteria, and the soil or

1 sediment would not cause a violation of any surface water quality
2 standard established under part 31 at the area of placement,
3 disposal, or use.

4 (d) Excavated soil from a site of environmental contamination,
5 corrective action, or response activity if the soil is not a listed
6 hazardous waste under part 111 and if hazardous substances in the
7 soil do not exceed generic soil cleanup criteria for unrestricted
8 residential use as defined in ~~part 201~~ **section 20101** or background
9 concentration as defined in ~~part 201~~, **section 20101**, as applicable.

10 (e) Construction brick, masonry, pavement, or broken concrete
11 that is reused for fill, rip rap, slope stabilization, or other
12 construction, if all of the following conditions are met:

13 (i) The use of the material does not violate section 3108, part
14 301, or part 303.

15 (ii) The material is not materially contaminated. Typical
16 surface oil staining on pavement ~~and or~~ concrete from driveways,
17 roadways, ~~and or~~ parking lots is not material contamination.
18 Material covered in whole or in part with ~~lead-based paint~~ **that**
19 **contains more than 0.5% lead** is materially contaminated.

20 (iii) The material does not include exposed reinforcing bars.

21 (f) Portland cement clinker produced by a cement kiln using
22 wood, fossil fuels, or solid waste as a fuel or feedstock, but not
23 including cement kiln dust generated in the process.

24 (g) Asphalt pavement or concrete pavement that meets all of
25 the following requirements:

26 (i) Has been removed from a public right-of-way.

27 (ii) Has been stockpiled or crushed for reuse as aggregate
28 material.

29 (iii) Does not include exposed reinforcement bars.

1 (h) Cuttings, drilling materials, and fluids used to drill or
2 complete a well installed pursuant to part 127 of the public health
3 code, 1978 PA 368, MCL 333.12701 to 333.12771, if the location of
4 the well is not a facility under part 201.

5 (i) Any material determined by the department under section
6 11553(5) or (6) to be an inert material, either for general use or
7 for a particular use.

8 **(7) "Innovative technology facility" means a materials**
9 **management facility that converts solid waste into energy or a**
10 **usable product and that is not a materials recovery facility, a**
11 **composting facility, or an anaerobic digester.**

12 **(8) ~~(5)~~"Insurance" means insurance that conforms to the**
13 **requirements of 40 CFR 258.74(d) and is provided by an insurer ~~who~~**
14 **that has a certificate of authority from the director of insurance**
15 **and financial services to sell this line of coverage. An applicant**
16 **for an operating license or general permit shall submit evidence of**
17 **the required coverage by submitting both of the following to the**
18 **department:**

19 (a) A certificate of insurance that uses wording approved by
20 the department.

21 (b) A certified true and complete copy of the insurance
22 policy.

23 **(9) ~~(6)~~"Landfill" means a ~~disposal area that is a sanitary~~**
24 **type II landfill or type III ~~landfill~~.**

25 **(10) "Landfill care fund" means a landfill care fund required**
26 **by section 11525d(2).**

27 **(11) "Landfill care fund bond" means a surety bond, an**
28 **irrevocable letter of credit, or a combination of these instruments**
29 **in favor of the department used to establish a landfill care fund.**

1 (12) "Large", in reference to a composting facility, means a
2 composting facility to which both of the following apply:

3 (a) The site at any time contains more than 500 cubic yards of
4 compostable material.

5 (b) The site does not qualify as a small or medium composting
6 facility.

7 (13) ~~(7)~~ "Lateral expansion" means a horizontal expansion of
8 the solid waste boundary of any of the following:

9 (a) A landfill, other than a coal ash landfill, if the
10 expansion is beyond the limit established in a construction permit
11 or engineering plans approved by the ~~solid waste control agency~~
12 **department or a certified health department** before January 11,
13 1979.

14 (b) A coal ash landfill, if either of the following applies:

15 (i) The expansion is beyond the limit established in a
16 construction permit issued after December 28, 2018.

17 (ii) The expansion is made after October 19, 2015, and is a
18 horizontal expansion of the outermost boundary, as defined by a
19 construction certification or operating license, of an existing
20 coal ash landfill.

21 (c) A coal ash impoundment, if the expansion is beyond the
22 limit established in a construction permit or the horizontal limits
23 of coal ash in place on or before October 14, 2015.

24 (14) ~~(8)~~ "Letter of credit" means an irrevocable letter of
25 credit that complies with 40 CFR 258.74(c).

26 (15) "License" means an operating license.

27 (16) ~~(9)~~ "Lime kiln dust" means particulate matter collected
28 in air emission control devices serving lime kilns.

29 (17) "Local health officer" means a local health officer as

1 defined in section 1105 of the public health code, 1978 PA 368, MCL
2 333.1105, to which the department delegates certain duties under
3 part 115.

4 (18) ~~(10)~~—"Low-hazard industrial waste" means industrial
5 material that has a low potential for groundwater contamination
6 when managed in ~~accordance~~ **compliance** with ~~this~~ part 115. ~~The~~ **All**
7 **of the** following materials are low-hazard industrial wastes:

- 8 (a) Coal ash and wood ash.
9 (b) Cement kiln dust.
10 (c) Pulp and paper mill material.
11 (d) Scrap wood.
12 (e) Sludge from the treatment and conditioning of water for
13 domestic use.
14 (f) Residue from the thermal treatment of petroleum
15 contaminated soil, media, or debris.
16 (g) Sludge from the treatment and conditioning of water from a
17 community water supply.
18 (h) Foundry sand.
19 (i) Mixed wood ash, scrap wood ash, and pulp and paper mill
20 ash.
21 (j) Street cleanings.
22 (k) Asphalt shingles.
23 (l) New construction or production scrap drywall.
24 (m) Chipped or shredded tires.
25 (n) Copper slag.
26 (o) Copper stamp sands.
27 (p) Dredge material from nonremedial activities.
28 (q) Flue gas desulfurization material.
29 (r) Dewatered grinding slurry generated from public

1 transportation agency road projects.

2 (s) Any material determined by the department under section
3 11553(7) to be a low-hazard industrial waste.

4 (19) ~~(11)~~—"Low-hazard-potential coal ash impoundment" means a
5 coal ash impoundment that is a diked surface impoundment, the
6 failure or ~~miseperation~~ **mis-operation** of which is expected to
7 result in no loss of human life and low economic or environmental
8 losses principally limited to the impoundment owner's property.

9 (20) "MAC" means the Michigan Administrative Code.

10 (21) "Managed material" means solid waste, diverted waste, or
11 recyclable material. Managed material does not include a material
12 or product that contains iron, steel, or nonferrous metals and that
13 is directed to or received by a scrap processor as defined in
14 section 3 of the scrap metal regulatory act, 2008 PA 429, MCL
15 445.423, or by a reuser of these metals.

16 (22) "Managed materials transporting unit" means a container,
17 which may be an integral part of a truck or other piece of
18 equipment, used for the transportation of managed materials.

19 (23) "Materials management facility" or, unless the context
20 implies a different meaning, "facility" means any of the following,
21 subject to subsection (24):

22 (a) A disposal area.

23 (b) A materials utilization facility.

24 (c) A waste diversion center.

25 (24) Materials management facility or facility does not
26 include a person, utilizing machinery and equipment and operating
27 from a fixed location, whose principal business is the processing
28 and manufacturing of iron, steel, or nonferrous metals into
29 prepared grades of products suitable for consumption, reuse, or

1 additional processing.

2 (25) "Materials management goals" means goals identified in
3 the MMP pursuant to section 11578(1)(a).

4 (26) "Materials management plan" or "MMP" means a plan
5 required under section 11571.

6 (27) "Materials recovery facility", subject to subsection
7 (28), means a facility that meets both of the following
8 requirements:

9 (a) Receives primarily source separated material and sorts,
10 bales, or processes the source separated material for reuse,
11 recycling, or utilization as a raw material or new product.

12 (b) On an annual basis, does not receive an amount of solid
13 waste equal to or more than 15% of the total weight of material
14 received by the facility unless the materials recovery facility is
15 making reasonable effort and has an education program to reduce the
16 amount of solid waste. Material disposed of as a result of
17 recycling market fluctuations is not included in the 15%
18 calculation.

19 (28) Materials recovery facility does not include any of the
20 following:

21 (a) A retail, commercial, or industrial establishment that
22 bales for off-site shipment managed material that it generates.

23 (b) A retail establishment that collects returnable beverage
24 containers under 1976 IL 1, MCL 445.571 to 445.576.

25 (c) A beverage distributor, or its agent, that manages
26 returnable beverage containers under 1976 IL 1, MCL 445.571 to
27 445.576.

28 (d) A facility or area used for reuse, recycling, or storage
29 of recyclable materials solely generated by an industrial facility.

1 (e) A facility that is an end user or secondary processor and
2 that uses as fuel or otherwise, processes, or stores material
3 generated by industrial facilities.

4 (f) A facility that primarily manages material that was
5 previously sorted or processed.

6 (g) An anaerobic digester.

7 (29) "Materials utilization" means recycling, composting, or
8 converting material into energy rather than disposing of the
9 material.

10 (30) "Materials utilization facility" means a facility that is
11 any of the following:

12 (a) A materials recovery facility.

13 (b) A composting facility.

14 (c) An anaerobic digester, except at a manufacturing facility
15 that generates its own feedstock.

16 (d) An innovative technology facility.

17 (31) ~~(12)~~"Medical waste" means that term as it is defined in
18 section 13805 of the public health code, 1978 PA 368, MCL
19 333.13805.

20 (32) "Medium", in reference to a composting facility, means a
21 composting facility to which all of the following apply:

22 (a) The site at any time contains more than 500 cubic yards of
23 compostable material.

24 (b) The site does not qualify as a small composting facility.

25 (c) The site does not at any time contain more than 10,000
26 cubic yards of compostable material.

27 (d) The site does not at any time contain more than 10% by
28 volume of class 1 compostable material other than yard waste.

29 (e) Unless approved by the department, the site does not at

1 any time on any acre contain more than 5,000 cubic yards of
2 compostable material, finished product, compost additives, or
3 screening rejects.

4 (33) ~~(13)~~—"Mixed wood ash" means the material recovered from
5 air pollution control systems for, or the noncombusted residue
6 remaining after, the combustion of any combination of wood, scrap
7 wood, railroad ties, or tires, if railroad ties composed less than
8 35% by weight of the total combusted material and tires composed
9 less than 10% by weight of the total combusted material.

10 (34) "Municipal solid waste" means household waste, commercial
11 waste, waste generated by other nonindustrial locations, waste that
12 has characteristics similar to that generated at a household or
13 commercial business, or any combination thereof. Municipal solid
14 waste does not include municipal wastewater treatment sludges,
15 industrial process wastes, automobile bodies, combustion ash, or
16 construction and demolition debris.

17 (35) ~~(14)~~—"Municipal solid waste incinerator" means an
18 incinerator that is owned or operated by any person, and **that** meets
19 all of the following requirements:

20 (a) The incinerator receives solid waste from off site and
21 burns only ~~household~~ waste from ~~single~~ **single-family** and ~~multiple~~
22 **multifamily** dwellings, hotels, motels, and other residential
23 sources, or such ~~household~~ waste together with solid waste from
24 commercial, institutional, municipal, county, or industrial sources
25 that, if disposed of, would not be required to be placed in a
26 disposal facility licensed under part 111.

27 (b) The incinerator has established contractual requirements
28 or other notification or inspection procedures sufficient to ensure
29 that the incinerator receives and burns only waste referred to in

1 subdivision (a).

2 (c) The incinerator meets the requirements of ~~this part and~~
3 ~~the rules promulgated under this part 115.~~

4 (d) The incinerator is not an industrial furnace as defined in
5 40 CFR 260.10.

6 (e) The incinerator is not an incinerator that receives and
7 burns only medical waste or only waste produced at 1 or more
8 hospitals.

9 **(36)** ~~(15)~~—"Municipal solid waste incinerator ash" means the
10 substances remaining after combustion in a municipal solid waste
11 incinerator.

12 **(37)** **"Municipal solid waste recycling rate" means the amount**
13 **of municipal solid waste recycled or composted, divided by the**
14 **amount of municipal solid waste recycled, composted, landfilled, or**
15 **incinerated.**

16 **(38)** ~~(16)~~—"New coal ash impoundment" means a coal ash
17 impoundment that first receives coal ash after ~~the effective date~~
18 ~~of the amendatory act that added this subsection.~~**December 28, 2018.**

19 **(39)** ~~(17)~~—"New disposal area" means a disposal area that
20 requires a construction permit under this part and includes all of
21 the following:

22 (a) A disposal area, other than an existing disposal area,
23 that is proposed for construction.

24 (b) For a landfill, a lateral expansion, vertical expansion,
25 or other expansion that results in an increase in the landfill's
26 design capacity.

27 (c) A new coal ash impoundment, or a lateral expansion of a
28 coal ash impoundment beyond the placement of waste as of October
29 14, 2015.

1 (d) For a disposal area other than ~~landfills~~ **a landfill** or
 2 coal ash ~~impoundments,~~ **impoundment**, an enlargement in capacity
 3 beyond that indicated in the construction permit or in engineering

 17 dwelling is part of a mixed use development and all dwelling units
 18 and associated outdoor residential use areas are located above the
 19 ground floor.

22 following materials if generated at a facility that produces pulp

24 (a) Wastewater treatment sludge, including wood fibers,
25 minerals, and microbial biomass.

26 (b) Rejects from screens, cleaners, and mills.

27 (c) Bark, wood fiber, and chips.

28 (d) Scrap paper.

29 (e) Causticizing residues, including lime mud and grit and

1 green liquor dregs.

2 (f) Any material that the department determines has
3 characteristics that are similar to any of the materials listed in
4 subdivisions (a) to (e).

5 (50) "Pyrolysis" means a process that does not involve
6 combustion and through which materials are heated in the absence of
7 oxygen until melted and thermally decomposed, and then are cooled,
8 condensed, and converted into other intermediate or final products.
9 If the feedstock is source separated material, pyrolysis is not
10 considered to be incineration, disposal, or processing of solid
11 waste.

14 **different manner, or use after reclamation.**

16 ashes, consisting of both combustible and noncombustible waste,
17 including paper, cardboard, metal containers, yard ~~clippings,~~
18 **waste**, wood, glass, bedding, crockery, demolished building

 18 product mixed with glue, resins, or filler.

19 (b) Wood or wood product treated with creosote or
 20 pentachlorophenol.

21 (c) Any wood or wood product designated as scrap wood in rules
 22 promulgated by the department.
