10 **GENERAL SECTIONS**

11 Sec. 201. In accordance with section 30 of article IX of the
 12 state constitution of 1963, total state spending from state sources
 13 in this appropriation act for the fiscal year ending September 30,
 14 2021 is \$37,789,600.00. State appropriations paid to local units of
 15 government are \$30,105,400.00 as follows:

 20 subject to the management and budget act, 1984 PA 431, MCL 18.1101

 23 **MICHIGAN NATURAL RESOURCES TRUST FUND**

24 Sec. 301. (1) The department of natural resources shall enter
 25 into agreements with local units of government to administer the
 26 grants identified in part 1. Among other provisions, the agreements
 27 must require that grant recipients agree to dedicate to public
 28 outdoor recreation uses in perpetuity the land acquired or
 29 developed; to replace lands converted or lost to other than public

1 outdoor recreation use; and, for parcels acquired that are larger
2 than 5 acres, to provide this state with a nonparticipating 1/6
3 minimum royalty interest in any acquired minerals that are retained
4 by the grant recipient.

5 (2) The agreements under subsection (1) must also provide that
6 the full payments of grants be made only after proof of
7 acquisition, or proof of completion of the development project, is
8 submitted by the grant recipient and all costs are verified by the
9 department of natural resources. This requirement may be waived by
10 the department of natural resources.

11 Sec. 302. The appropriations in part 1 for capital outlay
12 carry forward at the end of the fiscal year, consistent with
13 section 248 of the management and budget act, 1984 PA 431, MCL
14 18.1248.

15 Sec. 303. (1) The state share of the following capital outlay
16 appropriation authorized in 2018 PA 165 for Michigan natural
17 resources trust fund projects that has since been withdrawn by the
18 grantee is reduced up to the amount indicated and the money lapsed
