A bill to amend 1971 PA 79, entitled  
"Age of majority act of 1971,"  
by amending section 3 (MCL 722.53).

**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

1           Sec. 3. **(1)** This act supersedes all provisions of law
