A bill to amend 1949 PA 300, entitled "Michigan vehicle code,"

by amending section 803r (MCL 257.803r), as amended by 2019 PA 88, and by adding section 803s.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 803r. The secretary of state shall deposit the service

- 1 of state shall develop and issue 2 legacy registration plates as

- 3 (a) One plate must be a blue registration plate that
